## **ISSUE**

## **HISTORY**

Administration developed the "Pop-up Patio Program" in 2021 for restaurants in the downtown core. The Program was designed in part to allow restaurant operators the ability to offset COVID-19 indoor seating restrictions by expanding capacity outdoors, and in part to stimulate streetscapes, and create a more vibrant and enjoyable experience for people visiting and walking the Downtown. Council approved the Pop-up Patio Program under Bylaw 2021-27 (Sidewalk Café and Pop-up Patio Bylaw) in May of 2021.

Implementation of this program also aligns with:

- The 2010 Official Community Plan Objective 7.1.1. to "Support a Vibrant Downtown" by maintaining a strong sense of community;
- The 2018 Downtown Plan—Big Action 2, which identifies a Pop-up Patio Program as a pilot project opportunity as part of core area arts and cultural programming;
- The "Lease, Encroachment and Property Use Policy" which provides the guidelines for outdoor, sidewalk, and street patios/decks on public and private property;
- The 2015-2050 Sustainability Plan which proposes enabling "street vendors along pedestrian routes" to support entrepreneurship and innovation; and
- The 2020-2030 Local Food & Urban Agriculture Study Goals/Potential Actions 3.4
   "Distribution and Retailing: Increase opportunities for distributing and retailing locally
   sourced and prepared foods" and 3.8. "Provide system-wide support to advance all food
   system actions."

The Pop-up Patio Program has been reviewed in conjunction with regulations, incentives, and best practices in patio program precedents used in other municipalities across Canada. Many jurisdictions provide incentives, including patio set-up grants and relief from application, permitting, and bagged parking meter fees and charges, either partially or in total. Widespread evidence shows that providing applicants with relief from fees and charges enhances economic stability and increases program uptake.

An Administrative cross-divisional committee was established to review the program's rollout and make recommendations on improvements based on feed-back from applicants and proponents. Eight Downtown restaurant businesses were consulted on the program.

Program topics such as the application process, applicable fees, patio construction costs, vendor staffing, public safety, weather impacts, and the program area extents were discussed. The existing policy criteria and applicable bylaw regulations were reviewed.

Unfortunately, while there were several sidewalk cafés in operation last year, no parking area pop-up patios were established in the 2021 season that would allow for evaluations to occur. However, the review committee acknowledged the significant financial barrier to a pop-up patio initiative that is imposed through the bagged parking meter fee.

Administration is therefore recommending a reduction of this fee through an amendment to the Fees and Charges Bylaw.

## **ALTERNATIVES**

- 1. Bring forward a bylaw to amend the Fees and Charges Bylaw with respect to the bagged parking meter fee for pop-up parking patios during the 2022 season.
- 2. Refer the program proposal back to Administration.

## **ANALYSIS**

## **Benefits of the Pop-up Patio Program**

Eating and drinking establishments have experienced some of the most significant negative economic impacts caused by the physical distancing requirements of COVID-19. The proposed program allows flexibility for businesses to either establish a sidewalk café or a pop-up patio, or a combination of the two to increase seating capacity.

Expanding areas for outdoor eating and drinking establishment seating:

- Creates opportunities for restauranteurs to enhance the customer experience and increase public confidence and commitment in supporting local businesses;
- Has been an effective COVID-19 mitigating measure for restaurant operators across Canada;
- Stimulates the potential for increasing revenue of food and beverage retail establishments because of the ambience of an outdoor setting immediately adjacent to the operator's place of business;
- Provides a powerful medium for increasing awareness and promoting the City's support for local business; and
- Enhances downtown walkability, livability, and general quality of life by providing variety and opportunities for more outdoor life in the streetscapes.

## Pop-up patio permit and parking meter fee considerations

Pop-up patios require development permit fees, which are currently set at \$400 per permit. Where a structure is physically constructed, a special inspection fee of \$75 is also charged.

It is estimated that parking area pop-up patio design requirements on metered streets will displace three parking stalls per patio, resulting in a potential monthly revenue loss to the City of \$1,539 per pop-up patio (\$513 per stall occupied).

Currently, the Fees and Charges Bylaw offsets this revenue loss with a 'bagged' parking meter fee of \$25/day. It is noted that this fee was reduced by 50% to \$12.50/day for the 2021 season.

As not all downtown streets are metered and the displacement of parking meter stalls under this program is dependent on applicant interest and location, it is difficult to project the potential seasonal revenue loss under the downtown-wide program.

For context, the typical costs for a pop-up patio are noted below:

To encourage the development of on-street pop-up patios, Council may consider making use of the parking spaces and associated permitting and inspection fees free. However, it should be acknowledged that permit related fees are supposed to be set to reflect the administrative cost of issuance and that by not charging a fee we pass the cost on to taxpayers.

Administration is not recommending a reduction in permitting and inspection fees but is recommending reducing the bagged meter fee to \$0. This is designed to address the significant cumulative cost of these fees that would be associated with a typical 3-stall popup patio area (approx. \$9K for a 5-month season). Should Council approve this amendment to the Fees and Charges Bylaw, this fee reduction would be applied to approved parking-area patios in the 2022 season. This reduced fee would expire at the end of the 2022 year and be re-assessed for the 2023 season.

## **ADMINISTRATIVE RECOMMENDATION**

THAT Council direct that Bylaw 2022-13, a bylaw to amend the Fees and Charges Bylaw to reduce the Bagged Meter fee for pop-up patios for the 2022 season, be brought forward for consideration under the bylaw process.

The new fee shall read as follows:

## **ISSUE**

Amendments to the Parkade Bylaw and the Lease, Encroachment and Property Use Policy are required to permit overnight parking for food vendors.

## **HISTORY**

The City of Whitehorse's Mobile Food Vendor Program encourages and promotes food truck vending within the Downtown core. The designated sites are located on public lands because of their high visibility and suitability for food vending.

The City of Whitehorse and Government of Yukon established seven public sites designated at three locations. Vendors are only permitted on sites that have been allocated to them through a lottery process held in April of each year. One of the three locations is the City Parkade at 3<sup>rd</sup> Avenue and Steele Street. Overnight parking within designated public parkades is prohibited.

The purpose of this report is to amend Section 5 of the Parkade Bylaw 2017-19 and Section 2.10.33 of the Lease Encroachment and Property Use Policy to permit overnight parking for authorized mobile food vendors in designated sites within a public parkade.

### **ALTERNATIVES**

- 1. Amend the Parkade Bylaw and the Lease, Encroachment and Property Use Policy to allow overnight parking of authorized mobile food vendors in a parkade.
- 2. Do not amend the bylaw or the policy.

## **ANALYSIS**

Big Action 2 (Core Area Arts and Cultural Programming) of the 2018 Downtown Plan called for the implementation of mobile retail and food services to attract more visitors to downtown.

Increased demand for outdoor dining during the COVID-19 pandemic has accelerated the growth of the global food truck industry which exceeds \$2 billion. Canada's food truck

industry is valued at \$350 million. There are 23 operators listed by the City, of which three have expanded into permanent storefront locations.

The mobile food vendor program is a fast growing contributor to economic growth in the City of Whitehorse, providing outdoor restaurant services; promoting community walkability and vibrancy; and supporting entrepreneurship, supply chains, and job growth.

According to Parkade Bylaw 2017-19, "a mobile food vendor shall not park a vehicle in a parkade between the hours of 11:00 p.m. and 7:00 a.m." Vendors at the 3<sup>rd</sup> Avenue and Steele Street parkade location operate at a disadvantage compared to those outside of City parkades by not having access to overnight parking. Overnight parking at the other locations are not in parkades and therefore not prohibited from overnight parking.

Granting permission for overnight parking at designated sites in public parkades will help balance the City's ability to manage competing vendors and ensure that rights of way and parkades are used for their intended purposes while making better use of them for community activity.

## **ADMINISTRATIVE RECOMMENDATION**

THAT Council direct that Bylaw 2022-14, a bylaw to amend the Parkade Bylaw to permit overnight parking for food vendors, be brought forward for consideration under the bylaw process; and

THAT section 2.10.33 of the Lease, Encroachment and Property Use Policy be amended to read as follows:

"2.10.33 Mobile food vendors shall cease operating by 11:00 p.m. but may be allowed overnight parking of vending units."

A bylaw to amend Parkade Bylaw 2017-19

NOW THEREFORE the Council of the Municipality of the City of Whitehorse in open meeting assembled, hereby ENACT AS FOLLOWS:

- 1. Parkade Bylaw 2017-19 is hereby amended by deleting the existing section 5 and substituting therefore a new section 5 that reads as follows:
  - "5. A mobile food vendor may be permitted to park in a parkade between the hours the hours of 11:00 p.m. and 7:00 a.m.
- 2. This bylaw shall come into full force and effect upon the final passage thereof.

## **ISSUE**

Council authorization to change the scope and project delivery of the Range Road and Two Mile Hill Road – Intersection Upgrades project.

## **REFERENCE**

- Range Road and Two Mile Hill Road Intersection Study (2020)
- Range Road Corridor Study (2020)

## **HISTORY**

The Range Road and Two Mile Hill Road intersection is a crossroads for a variety of road users including pedestrians, cyclists, transit users, commercial goods movement, drivers, and emergency response. The junction conveys people between outer neighbourhoods, regional destinations, and the downtown core for employment, education, economic, and recreation purposes. The intersection is in close proximity to numerous destinations and facilities owned by both the City and the Government of Yukon.

Administration has received a high volume of public complaints about this intersection. The majority of complaints relate to road safety as a result of the spacious and confusing geometry and active transportation facilities that can be uncomfortable for road users. There is also considerable concern with vehicular traffic "queuing" on Range Road southbound during the morning peak times, particularly when school is in session.

## Range Road and Two Mile Hill Road – Intersection Study (2020)

In 2020, Administration partnered with a consultant to develop the "Range Road and Two Mile Hill Road – Intersection Study." This project included identification of issues, public engagement, and conceptual design development to inform future project phases. Public feedback received for the project was mixed and there was no significant support expressed for a preferred design option. Since the completion of the study, Administration has continued to field concerns from the public with proceeding with the project's recommendations. Public concerns primarily centered on the suitability of the design concept(s) in meeting their transportation needs and desires.

# **Additional Design Considerations and Opportunities**

In 2020, Administration completed the "Range Road Corridor Study", which identified the need for active transportation improvements along Range Road to improve multimodal transportation safety and connectivity. Additionally, the "Range Road South Asphalt Path Extension Project", started in 2021 and is slated for completion in 2022. Because the Range Road Corridor Study and Range Road South Asphalt Path Extension were

completed after the intersection study, both of these were not originally considered in the original study and will necessitate changes in the upcoming project detail design phase.

The Government of Yukon has recently indicated interest to implement upgrades at the Alaska Highway and Hamilton Boulevard/Two Mile Hill Road intersection in the near-term development horizon (0-5 years). In preliminary discussions between Engineering Services and the Transportation Engineering Branch, Yukon has indicated interest in expediting upgrades at this intersection to integrate and coordinate with the City's project at Range Road and Two Mile Hill Road.

The "Range Road and Two Mile Hill Road – Intersection Study" recommended conceptual design options that were formulated on the best knowledge of the design criteria at the time and the limited scope of study area which was confined to the single intersection. The additional design criteria and major capital improvement coordination opportunities that have arisen since the original intersection study in 2020 are likely to render any of the conceptual design options largely ineffective in meeting the existing and broader future transportation needs. Administration is also aware of mixed and inconclusive public feedback towards past public engagement processes related to this project.

## **Proposed Change in Scope and Project Delivery**

The evolving planning context, design considerations, and coordination opportunities present an opportunity to revaluate and partner with the Government of Yukon to integrate these two projects. As such, Administration recommends that Council consider a proposed change in project scope and project delivery that includes the following:

- Increase the study area of the project to include Range Road and Two Mile Hill Road and the Alaska Highway and Hamilton Boulevard/Two Mile Hill Road intersections and intersection approaches.
- 2. **Re-evaluate transportation functional planning** of both the Range Road and Two Mile Hill Road and Alaska Highway and Hamilton Boulevard/Two Mile Hill Road intersections together.
- Manage a single expanded project that considers both intersections but is project managed by the City of Whitehorse with support, collaboration, and a funding contribution from the Government of Yukon.

## **ALTERNATIVES**

- 1. Authorize Administration to change the project scope and project delivery and engage with the Government of Yukon to develop an agreement for the project.
- 2. Refer the matter back to Administration for further analysis.

## **ANALYSIS**

The proposed change in scope and project delivery will allow for comprehensive reevaluation of transportation planning for both intersections in light of the additional design criteria and opportunities made known since the original study. From a transportation planning perspective this is beneficial because the two intersections functionally operate together and the design outcomes of each intersection have significant implications on each other. It will also allow for an integrated design approach for both intersections that considers and meets the functional transportation needs for all road users, interested parties, and both governments.

The proposed change and project delivery allows for a combined project managed by the City in partnership with the Government of Yukon. A combined project allows for increased collaboration, coordination, construction, and project management efficiencies and provides an integrated public engagement process that will be efficient and easier to follow by the public.

The proposed change in scope and project delivery will provide additional opportunities, checks and balances for the public and both governments to ensure the project aligns with shared vision, values, goals, and priorities and maximize benefits to cost. Preliminary vision and goals include working towards zero traffic-related injuries and fatalities, and providing high quality transportation facilities for all modes of transportation (walking, cycling, transit, and driving) and all ages and abilities.

The proposed change in scope and project delivery is likely to impact overall project costs borne by the City's contribution. There will be additional costs associated with additional planning work and construction work depending on the design outcome. Impacts to project costs will be further explored and detailed following discussions with the Government of Yukon.

The proposed change in scope and project delivery is likely to impact project schedules as additional time for transportation planning, public engagement, and detail design will be required. As a worst-case scenario, Administration estimates that construction start could be delayed from 2023 to 2024 and may need to be phased over two construction seasons depending on the design and implementation. Administration recognizes significant public desire for timely upgrades in this area however this should be carefully weighed against the potential social, economic, and environmental benefits delivered by the change in scope.

It is anticipated, considering feedback on previous design processes to date, that the public will welcome additional opportunities to reimagine both intersections with the City and the Government of Yukon.

The next steps would be for Administration to develop an agreement with the Government of Yukon that will inform a future request to increase the project budget.

## ADMINISTRATIVE RECOMMENDATION

THAT Council authorize Administration to change the project scope and project delivery and engage with the Government of Yukon to develop an agreement for the Range Road and Two Mile Hill Road – Intersection Upgrades project.

## **ISSUE**

Appointment of citizens to the Recreation Grant Task Force

## **HISTORY**

The Recreation Grant Task Force has been in place since 1998. Task Force members are residents of Whitehorse and volunteers that have an interest in recreational activities and sport development within our community. Their role is to review recreation grant applications and provide recommendations to Council twice yearly.

## **ANALYSIS**

The membership of the task force consists of between seven to nine citizens who have been recommended by Recreation and appointed by Council. A public process is used to invite applications. Applications are reviewed by Recreation and recommendations brought forward to Council for approval.

The call for applications occurs as required to maintain the membership complement to review the regular cycle of grant applications (in this case the next set of applications is March 15). Each member serves a term of five years. Terms of individual members are staggered by one year to ensure continuity of service.

The current term for three of the Taskforce members has expired. In accordance with the Recreation Grant Policy, the City publicly advertised for new members and has received two new applicants, Adrienne Marsh and Benjamin Monkman. Existing member Jane Keopke has offered to serve another term. The proposed members have agreed to have their names go forward for Council consideration.

Adrienne has been involved in recreation for her entire career, has government and notfor-profit experience, and has a good understanding of the recreational and sport environment in the Yukon. Ben is a youth support outreach worker for Ta'an Kwach'an Council and has a good understanding of youth and community needs. All members of the Task Force have extensive involvement in community activities and possess the leadership experience required.

Administration acknowledges and thanks outgoing task force members Caili Steele, and Marilyn McPhee as longstanding contributors to this program.

## **ALTERNATIVES**

- 1. Approve the appointment of Adrienne Marsh and Benjamin Monkman and the reappointment of Jane Keopke as members of the Recreation Grant Task Force.
- 2. Refer the proposed appointments back to Administration for further consideration.

## **HISTORY**

Yukon is currently experiencing the highest per capita rate of opioid related deaths in Canada. In 2022, there have already been eight deaths due to opioid abuse. These events led the Government of Yukon to declare a substance-use health emergency on January 20<sup>th</sup>, 2022.

A donation to the Blood Ties Four Directions Centre in the amount of \$2,000.00 has been suggested as a gesture that could be made by the City to support the community through this organization. Sufficient funds are available in the Council donations account.

## <u>ADMINISTRATIVE RECOMMENDATION</u>

THAT a grant of \$2,000.00 be authorized to the Blood Ties Four Directions Centre, funded from Council's Donations account, for use as the Centre sees fit to assist in addressing the current opioid crisis affecting Yukon.
