## Commitment to not Create Smoke or Grease-laden Cooking Vapours

This form is required for installations where it is proposed to use *Class 1* cooking appliances for *Class 2* cooking. The following commitment is given to the city.

*Class 1* and *Class 2* cooking operations are defined for the purpose of this form as follows:

**Class 1** cooking operations is any cooking process which produces smoke or grease-laden vapours, and includes equipment which has been designed by the manufacturer to be able to produce smoke or grease-laden vapours, except where specifically approved under *Class 2*. Examples of *Class 1* cooking (grease or smoke): pan frying, frying onions in a soup pot, deep frying, grilling, broiling, stir frying and braising.

**Class 2** cooking operations are defined as any cooking equipment or process which produces significant steam or heat and does not produce grease-laden vapours. Examples of *Class 2* cooking (non-grease): Boiling water (potatoes, pasta, rice, poached eggs) reheating pre-made soups and heating beverages.

The undersigned, who is the business operator of the cooking operation, acknowledges that the appliance(s) chosen to be used has been designed with the potential for *Class 1* cooking. The undersigned commits to limit all use of this appliance(s) to *Class 2* cooking.

The undersigned acknowledges that the proposed ventilation system has not been designed to comply with the requirements for a *Class 1* cooking operation and acknowledges that, if *Class 1* cooking is conducted on the appliance(s), the ventilation system will be considered in unsafe condition.

If the cooking operation is found by the city to be in breach of this commitment and if ordered by the City, the operator of the cooking operation commits to removing the appliance(s) until a ventilation system is installed to the satisfaction of the Chief Building Official and the Fire Chief.

The operator commits to installing and maintaining portable fire extinguishers in compliance with *The National Building Code of Canada*.

In addition to the above, prior to the use of the appliance(s), the operator of the cooking operation commits to ensuring that a metal sign(s) is securely mounted to the front of the hood(s) embossed with the following words, sized and coloured so that they can be easily read and understood. The operator also commits to maintaining the sign(s) in place and its readability throughout the operator's responsibility of the cooking operation. The sign(s) is required to be indicated on the building permit drawing.
