At a special council meeting on April 9th council considered a motion to temporarily suspend enforcement of section 11 of Schedule D of the Waste Management Bylaw. This would allow residents to dispose of cardboard as residual waste. At that time members of council expressed concern about allowing cardboard to be deposited at the landfill and encouraged residents to seek out other options in the community. Administration was asked to do a full assessment of possible options instead of allowing the disposal of cardboard as residual waste at the Waste Management Facility.

Please be advised there will be a Public Hearing at the Regular Council Meeting of April 27, 2020, to hear from interested parties related to the following Official Community Plan (OCP) amendment:

Bylaw 2020-10, a bylaw to amend the 2010 Official Community Plan to allow for commercial/industrial development on a portion of the Upper Tank Farm property.

In 2011, Environment Yukon designated the Tank Farm as a contaminated site which means it is subject to the Yukon Contaminated Sites Regulations under the *Environment Act*. It gives the Government greater authority over remediation activities on the property so as to ensure the protection of human health and the environment. The entire site is designated as Residential – Urban in the 2010 Official Community Plan and has been designated for long range residential development since the 1987 OCP.

In May 2012, engagement was undertaken on the future of the Tank Farm, which included meetings with the Government of Yukon, City of Whitehorse, Kwanlin Dün First Nation, Ta'an Kwäch'än Council, the general public, and nearby community associations. This work cumulated in the creation of the preferred concept which divides the Tank Farm into an urban residential neighbourhood on the western (upper) portion of the site and a mixed use industrial/commercial area on the eastern (lower) portion of the site.

In December 2012, Council approved an OCP amendment to allow for remediation and quarrying activities in order to clean up the site for future development. The amendment allowed for on-going remediation activities including clearing, excavation, crushing, land treatment facilities, and the removal of soil. During the remediation process, the site has undergone significant re-contouring. 3 Pikas, acting on behalf of the owner of the Tank Farm site, has applied to amend the OCP to facilitate industrial/commercial development on a portion of the site.

Bylaw 2020-10 received First Reading on March 30, 2020. Notices were published in the newspapers on April 3 and 9 and a copy of the notice was sent to the Minister of Community Services, as per the *Municipal Act*. A total of 294 letters were sent to property owners within 1000 m of the parcel. Yukon Government Land Client Services, Kwanlin Dün First Nation, Ta'an Kwäch'än Council, and the Hillcrest and Valleyview Neighbourhood Associations were notified by mail.

1. **Spring Recreation Grant Allocations**

In accordance with the Recreation Grant Policy, the Recreation Grant Task Force has prepared recommendations for the allocation of the 2020 Arts–Cultural Facilities Grants, Recreation Facility–Parks Grants, and Spring Recreation Grants.

The Task Force consists of citizens appointed by Council, and all applications are reviewed with due diligence. A total of 27 grant applications were received and reviewed by the Task Force. Some applicants are recommended for less funding than requested due to the terms and conditions specified in the Recreation Grant Policy and changes in funding parameters for Lotteries funding.

The Community Lotteries Program provided \$197,176.00 for Recreation Grant purposes this year. The City continues to acknowledge the support of Lotteries funding in City advertising.

1. Budget Amendment – Downtown Speed Reduction Study

At a meeting to review the Second Avenue Corridor Study, Council members asked for more specific information on the option of a blanket speed reduction for the downtown area from 50 kilometres per hour to 40 kilometres per hour. In order to obtain a better understanding of the effectiveness and impacts of such a change, administration is proposing that an engineering study be completed before bringing the matter forward for further consideration. The proposed study would also provide an indication of the estimated costs to implement a speed reduction.

In response to questions raised, administration confirmed that the proposed study would look at the suitability of a speed reduction for the downtown area as a means to address the safety issues identified. The study would examine a variety of parameters such as the geography and geometry of the roads, speed data, and existing available enforcement. The consultant will analyze the pros and cons of a blanket speed reduction and provide recommendations and implementation strategies.

The recommendation of the Corporate Services Committee is

THAT the 2020 to 2023 capital expenditure program be amended to provide for the creation of a new 2020 capital project for a Downtown Speed Reduction Transportation Engineering Study in the amount of \$15,000, funded by the Capital Reserve.

2. <u>Budget Amendment and Contract Award – Rural Roads Surfacing Project</u>

The 2020 capital budget includes funds for the resurfacing of a number of rural roads and intersections in various areas of the City. The project will resurface roads with bituminous surface treatment and pave intersections with warm mix asphalt. One bid was received in response to the tender issued. The internal review committee agreed that the sole bidder is familiar with the scope of the work and has the skills and ability conduct the work successfully. The prices submitted are over budget but are reasonable given the current uncertainty around delivering construction projects.

A budget amendment is required to provide the additional funds. An amendment to the current Gas Tax agreement will also be required.

The recommendation of the Corporate Services Committee is

THAT the 2020 to 2023 capital expenditure program be amended by increasing the 2020 Rural Roads Surfacing project in the amount of \$35,000, funded by Gas Tax to cover additional costs and; and

THAT administration be authorized to award the contract for the 2020 Rural Roads Surfacing Project to Skookum Asphalt Ltd. for a net cost to the City of \$419,937.51 plus GST.

RE: Contract Award – Consulting Services – Services Building Project

ISSUE

The issue is authorizing the award of the contract for consulting services for the Services Building project.

HISTORY AND KEY INFORMATION

The 2020 Capital Budget includes funding for consulting services for the design and construction supervision of the Services Building project. Four proposals were received in response to the request for proposals issued. Two proposals did not meet the minimum technical threshold required to continue to stage two of the evaluation process. A third proposal was deemed non-compliant by the evaluation committee. The successful bid is within the approved capital budget.

The total project budget is \$20.8 million with the majority of the funds provided by government grants. Timely award of the consultant services contract is required in order to be able to complete the design in time to tender construction in 2021 and complete the work by March 2023, the date specified in the funding agreements with the federal and Yukon governments.

At its April 14th, 2020 meeting, Council asked for more information regarding the procurement process to date and postponed its decision about the proposed contract award to the regular meeting on April 27, 2020.

Administration has determined that there is no evidence that this procurement was conducted other than in conformance with City policy. A legal review was sought of the procurement process to date. In summary, legal counsel concluded that:

- There are objectively reasonable grounds to reject three of the four bid proposals, leaving only Kobayashi + Zedda Architects' bid; and
- Kobayashi + Zedda Architects' prior involvement in the project is permitted under Canadian procurement law and there is no evidence that any bidder received an unfair advantage in the process; and
- While the City has legal grounds for cancelling this RFP, issuing a new RFP for the Services Building project will involve legal risk for the City based on a duty of fairness, given that the prices submitted by two of the four proponents have been revealed publicly.

CITY OF WHITEHORSE BYLAW 2020-11

A bylaw to assign names for new municipal buildings.
WHEREAS section 265 of the <i>Municipal Act</i> (R.S.Y. 2002) provides that council may by bylaw name a building; and
WHEREAS a new municipal fire hall is being constructed at 105 Black Street and a new municipal operations building is being constructed at 187 Range Road; and
WHEREAS it is deemed desirable to officially name new municipal facilities, including buildings;
NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:
1. The new fire hall is hereby named "Whitehorse Fire Hall #1".
2. The new operations building is hereby named "Whitehorse Operations Building".
3. This bylaw shall come into full force and effect upon the final passing thereof.
