Work on the study was carried out primarily by City staff with contributions from consultants. The project team connected with other governments, industry representatives, associations, businesses and gardening groups, as well as residents active and interested in food and agriculture topics. The project team also reviewed policies, regulations, and initiatives that have worked well in other municipalities and have potential for success if implemented in Whitehorse.

The draft study was released for public comment in August and the study was updated to reflect the input received. The study will be used to inform the Official Community Plan review process.

Policies and objectives for the plan are being drafted to reflect the findings of the study. Future implementation work is anticipated to include review and updates of the City's Zoning Bylaw, Animal Control Bylaw, and Business License Bylaw.

If members of the public are interested in taking on project ideas identified in the study, some funding is available through the City's Environmental Grant program.

DECLINE 2021 SALARY ADJUSTMENT FOR ALL MEMBERS OF COUNCIL Councillor Hartland explained that he brought the motion forward as a way for council to keep costs down and show leadership while the business community is suffering due to the COVID-19 pandemic.

Administration confirmed that passing this motion will have no impact on the base annual salary for future councils. The bylaw that will set the remuneration for the next term of council, scheduled to be voted on later in this meeting, sets a new base rate for mayor and council based on the rates established in the current bylaw. This motion does not amend the current bylaw; it merely declines the 2021 adjustment that members of council are entitled to under that bylaw.

Members of council spoke to their reasons for supporting the motion, stating their agreement with making a symbolic gesture and leaving it to administration to determine where the money saved will be used.

Some members expressed a desire to put more emphasis on substantive actions that council can do to assist the community in the coming year. One member suggested that council should look at giving direction to administration to move ahead with certain initiatives so that systems are in place to support the business community in time for the start of the summer season next year.

1. OCP Amendments – Whistle Bend Future Area C

The Government of Yukon, as the primary land owner and developer in Whistle Bend, has indicated a desire to proceed with detailed engineering for Future Area C in early 2021. This work is required to ensure there is a continuous supply of available building lots in the coming years. Amendments to the Official Community Plan are required before any work can proceed.

The proposed amendments to the Official Community Plan would change the existing land use designations of areas identified as "Recreation" and "Green Connections" to "Designated Development". Portions of "Environmentally Sensitive" areas along the Yukon River and adjacent to Porter Creek would be maintained.

The extension of the Whistle Bend neighbourhood into Area C meets the objectives of the Official Community Plan for development that uses existing servicing infrastructure, promotes active transportation and transit use, and includes residential, commercial and institutional uses to create complete communities.

The recommendation of the City Planning Committee is

THAT Bylaw 2020-31, a bylaw to amend the Official Community Plan to allow for the development of the area known as Whistle Bend Future Area "C", be brought forward for consideration under the bylaw process.

1. Fall Recreation Grant Allocations

The Recreation Grant Task Force reviewed 13 applications for fall recreation grants in accordance with the Recreation Grant Policy. Funding provided by Community Lotteries may not be used for operating and maintenance costs, and therefore the grant recommendations do not match the grant requests for some organizations.

The recommendation of the Community Services Committee is

THAT the allocation of \$46,680 for Recreation Grants as recommended by the Recreation Grant Task Force be approved; and

THAT any unexpended recreation grant funds, as well as any refunds received prior to year-end, be authorized for re-budgeting to 2021.

2. <u>Festival and Special Event Grant Allocations for 2021</u>

The Festival and Special Event Grant fund is governed by Council Policy. This year 13 applications were received, of which 11 were determined to be eligible in accordance with established criteria. The evaluation committee reviewed and rated the eligible applications and made recommendations for financial and in-kind support. Full allocation of the funding available was recommended to the eligible groups, including two signature events. In-kind requests were assessed by impacted departments to ensure that they can be accommodated within regular operating hours.

The recommendation of the Community Services Committee is

THAT the recommendations for Festival and Special Event Grant Fund allocations for 2021 be approved as presented, with funding from the 2021 budget.

3. <u>Local Content Weighting – Consultant Services – Campground Building</u>

The City intends to build a new facility at the Robert Service Campground that will serve as the main reception base for the operation of the campground. It will also be used as a community hub that can be accessed year round, with flexible uses such as recreation, community gatherings, and rentable space for other organizations.

Administration is preparing to release a request for proposals for consultant services for the design and construction supervision of the campground building. It is proposed that the local content weighting be set at the maximum, which is 20 points. This rating recognizes that there are many local companies qualified to do this work that also have knowledge of the City and the current construction market.

The recommendation of the Community Services Committee is

THAT administration be authorized to set the weighting for local content at 20 points in the request for proposals to be issued for design and construction services for the Robert Service Campground Building.

1. Budget Amendment – Emerging Pollutants Wastewater Treatment

Wastewater treatment science is evolving to address the treatment of emerging contaminants such as pharmaceuticals, personal care products, hydrocarbons and micro-plastics. Systematic testing has not been done to quantify contaminants in our wastewater system, and our primary sewage treatment facility is not designed to treat them.

Although regulations are not currently in place, a capital project was established to sample and assess contaminants in 2020, prepare a conceptual design of a treatment system in 2021, and implement a treatment pilot project in 2023. Gas Tax funding was obtained, but quotes obtained for these services came in at a much higher cost than anticipated. An amended Gas Tax agreement has been approved to cover the additional costs, but a budget amendment is required.

The recommendation of the Corporate Services Committee is

THAT the 2020 to 2023 capital expenditure plan be amended by increasing the Emerging Pollutants Wastewater Treatment project to \$70,000 for 2020, funded by Gas Tax.

2. Urban Electrification Program

In 1989 the City began assisting with the cost of electrifying urban property by financing the work and charging the cost back to the property as a local improvement charge. In order to have an application approved the applicant must have title to the property, current taxes must be paid in full, and the cost of the work must not exceed 75% of the assessed value of the property. The owners of the property located at 24 Harvey Place in the Pineridge subdivision have met all the conditions of the urban electrification program. A bylaw is required to provide for a work of local improvement.

The recommendation of the Corporate Services Committee is

THAT the application under the urban electrification program for Lot 57 in the Pineridge Subdivision, Whitehorse Plan No.93-134, be accepted; and

THAT Bylaw 2020-23, a bylaw to authorize a local improvement charge for urban electrification at Lot 57, Pineridge Subdivision, be brought forward for consideration under the bylaw process.

- Management and Confidential Exclusion Bylaw 2020-30 is hereby amended by deleting existing sections 45 and 46 and substituting therefore new sections 45 and 46 as follows:
 - "45. Employees with a continuous service date before October 1, 2016 and who receive pay for at least ten days in a calendar month are entitled to vacation leave in accordance with the following schedule:

CITY OF WHITEHORSE BYLAW 2020-23

A bylaw to authorize a local improvement charge for urban electrification

WHEREAS in 1989 council approved the concept of assisting taxpayers to bring electrical service to their property via the imposition of a local improvement charge; and

WHEREAS the owners of the property located at Lot 57, Pineridge Subdivision, Whitehorse YT, have applied under the Urban Electrification Program for a local improvement to assist them in providing power to the property; and

WHEREAS sections 267 to 271 of the *Municipal Act* require that a bylaw to provide for and authorize a local improvement will contain specific information pertaining to the local improvement and the procedures to be followed in passing the bylaw; and

WHEREAS the actual cost of the said construction is estimated to be \$4,305.00 of which \$4,305.00 will be raised by way of a special tax assessment, and

WHEREAS in order to construct and complete the project it will be necessary to fund up to the sum of \$4,305.00 from the City; and

WHEREAS the estimated life of the project exceeds ten years;

NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- A work of local improvement, being the electrification of the property described as Lot 57, Plan No.93-134, Pineridge Subdivision, Whitehorse YT Roll #3500005700, property class RSC, located at 24 Harvey Place, is hereby authorized.
- 2. The parcel of land benefiting from this work of local improvement is as set out in section 1 of this bylaw.
- 3. The total cost of the local improvement has been determined by ATCO Electric Yukon.
- 4. The cost of the work is to be paid for by way of a special assessment to be levied on the parcel described in section 1 of this bylaw.
- 5. For the purposes aforesaid, the sum of up to \$4,305.00 is to be funded by the City.
- 6. The sum of \$4,305.00 is to be collected by way of a special assessment as provided in section 7 of this bylaw.
- 7. There is hereby imposed on the land described in section 1 of this bylaw a special assessment under the Assessment and Taxation Act. This equates to an annual fee in the amount of \$490.61 for each of ten years. This sum is the amount

necessary to pay the annual amount of interest and principal falling due in each year, computed at the prime business rate of 2.45% as at October 06, 2020. The said special assessment shall be in addition to all other rates and taxes.

- (1) The property owners have the option of paying the total property charge prior to its due date, or of paying the equal annual instalments each of ten years, commencing on July 2, 2021.
- (2) The property owners may reduce the balance owing on the total property charge by making a lump sum payment in any year during the life of the bylaw. Such lump sum payments shall be accepted only in the month of January each year.
- (3) The property owners may also pay off the balance owing at any point during the ten-year life of the bylaw.
- 8. The provisions of this bylaw shall come into full force and effect upon final passage thereof.

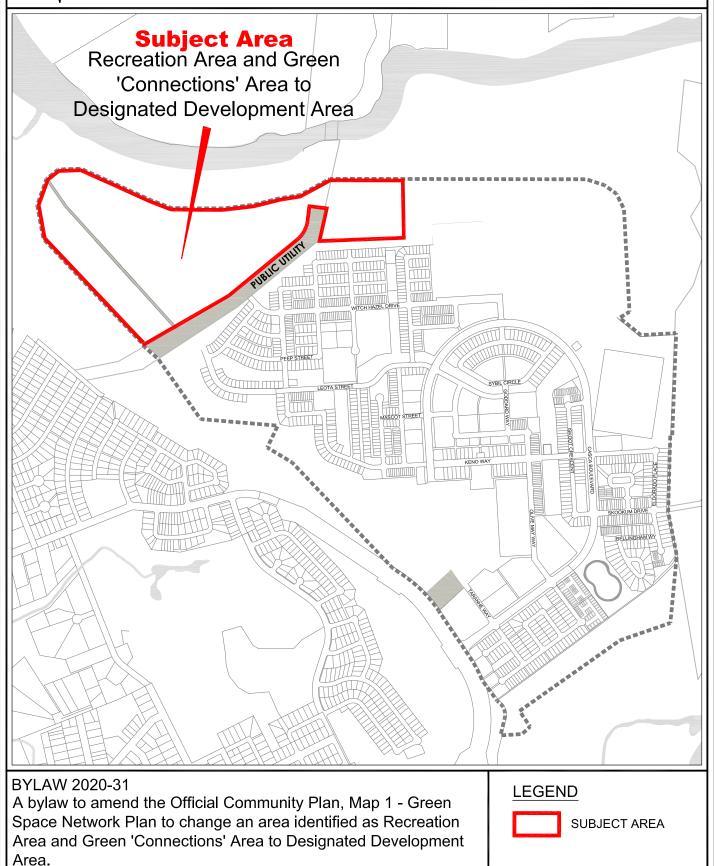
NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- 2. Map 2 of Official Community Plan Bylaw 2010-01 is hereby amended by changing the designation of a 56.3-hectare area known as Future Area C from Greenspace to Residential-Urban as indicated in Appendix "B" forming part of this bylaw.
- 3. Map 5 of Official Community Plan Bylaw 2010-01 is hereby amended to extend the area identified as Undeveloped Public Land to include the 56.3-hectare area known as Future Area C as indicated in Appendix "C" forming part of this bylaw.
- 4. This bylaw shall come into force and effect upon the final passing thereof.

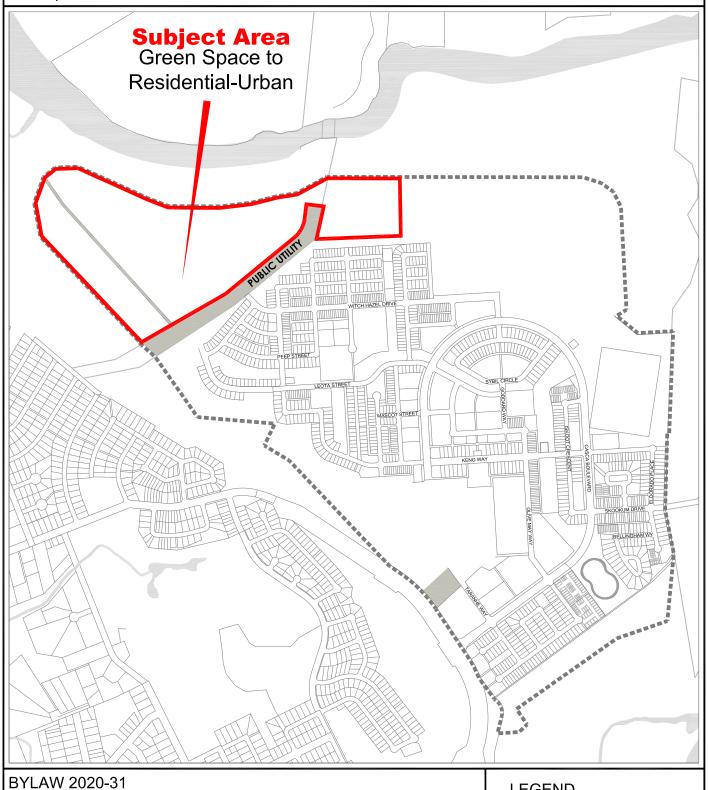

A bylaw to amend the Official Community Plan, Map 2 - Area Land Use Designations to change the designation of an area from Greenspace to Residential - Urban.

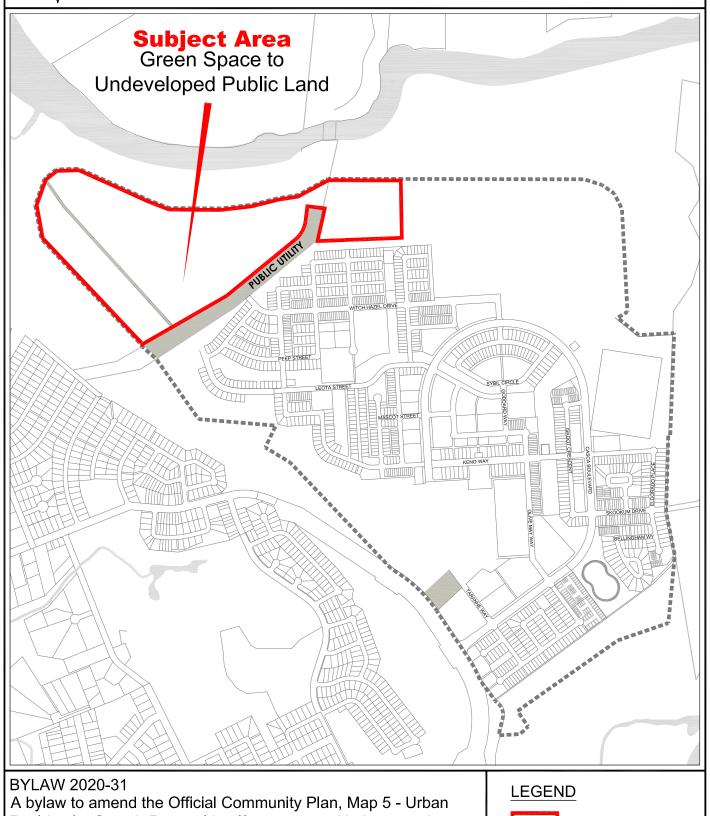
