**RE**: Arctic Winter Games 2026 Hosting Opportunity

### <u>ISSUE</u>

Hosting the 2026 Arctic Winter Games (the Games, or AWG).

#### <u>HISTORY</u>

The Games is a high profile circumpolar youth sport competition for northern and arctic athletes that provides an opportunity to strengthen sport development, promote the benefits of sport, build partnerships, and highlight culture and values of northern regions around the world.

Typically held on a two-year rotational basis, the Games occur for the regions of Alaska, Northwest Territories, Nunavut, Northern Alberta, and the Yukon, and have also been hosted in Nuuk, Greenland. The Yukon was set to co-host in 2020, but the Games were cancelled shortly before the event due to onset of the COVID pandemic. The normal rotation would have seen the 2026 games in Yamal, Russia, however due to the conflict involving Russia and Ukraine, the Arctic Winter Games International Committee (AWGIC) suspended Yamal's participation, resulting in the absence of a host.

The Northwest Territories, originally slated to host the Games in 2028, were approached with the possibility of advancing their hosting role but declined the opportunity.

In June 2023, the Yukon Government (YG) received a letter from the AWGIC with an invitation to consider the possibility of the Yukon, particularly the City, hosting the Games in 2026. A response to the AWGIC indicating an intent to host is required by July 31, 2023.

Although the City hasn't been formally asked to host the Games, the community has significant experience holding multi-sport events, having hosted the 2007 Canada Winter Games, 2012 Arctic Winter Games, and were preparing to co-host the 2020 AWG.

The Games is an important opportunity for the approximately 3000 young athletes, coaches, officials and is key to sport development in the Yukon and circumpolar north, and can generate significant economic impact. The 2020 Arctic Winter Games was expected to contribute approximately \$5.7 million to Yukon's economy, and that number is expected to increase for 2026.

If the City agrees to host the Games, they would enter into negotiations to sign a contract with the AWGIC, and begin the process of forming a Host Society to deliver the Games.

The role of the Host Society is to stage the Games, and includes responsibilities such as developing a budget, securing sponsorships, coordinating logistics and transportation, and selecting sports and cultural events. The Host Society would be comprised of a Board of Directors, salaried employees, and the many volunteers that help deliver the Games. The role of the Society's Board of Directors is to approve major decisions in accordance with AWGIC policies and standards, and this board would consist of representatives from the City, community and YG.

### ALTERNATIVES

- 1. Advise YG that Whitehorse is prepared to host the 2026 AWG, subject to confirmation of YG commitments, and authorize Administration to enter into contract negotiations with the AWGIC; or
- 2. Advise YG that the City is not willing to consider hosting the 2026 AWG.

#### ANALYSIS

In Canada, Host Societies normally receive grants from the Government of Canada (Heritage Canada-Sport Canada), together with territorial governments, and host municipalities, which may include in-kind donations. In recent years, the cost of hosting the Games has ranged from \$7 million to more than \$13 million. Using information from 2020 AWG budget and audited financial statements, it is estimated that the 2026 Games could cost approximately \$9.55 million, reflecting a 22% increase over budgeted costs for 2020.

This estimate includes a cash contribution of \$250,000 from the City, in addition to a \$500,000 contribution of in-kind support from the City for use of facilities and staff time.

The City's cash contribution is consistent with previous years, and would come forward for approval under the budget process.

\$9.55 million represents an early preliminary budget and the amounts indicated could change depending the funding provided by both the Federal and Territorial Governments, any additional revenues and market challenges. The final budget would be developed by the Host Society once formed.

If Council is willing to proceed, the next step would be to advise YG that the City will consider hosting the Games subject to YG committing to provide \$4 million in funding, plus in-kind staff support as required by the Host Society. YG would also have to commit to underwrite any deficit incurred by the Host Society in order for the City to agree to host the Games. These commitments would need to be confirmed by July 28, 2023, prior to the AWGIC deadline at the end of July. This timeframe still allows time for discussion and negotiation including sport selection and any other area within the contract developed with the AWGIC and with the Host Society once it is formed.

#### **ADMINISTRATIVE RECOMMENDATION**

THAT Council advise Yukon Government that the City is prepared to host the 2026 Arctic Winter Games, subject to receipt of Yukon Government financial and other commitments by July 28, 2023; and

THAT Council authorizes Administration to enter into negotiations with the AWGIC.

#### <u>ISSUE</u>

Council approval for commencement of the procurement for design and construction of the downtown Transit Hub and approval of a budget amendment.

#### **REFERENCE**

- Procurement Policy 2020-03
- 2023-2026 Capital Expenditure Program 360c00923 Transit Hub

#### <u>HISTORY</u>

In accordance with Section 3.1.1 of the Procurement Policy, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more and of procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest. This procurement is anticipated to be over \$500,000.

Through part of 2022 and early into 2023, Administration worked with a consultant to conduct a feasibility study to analyze the old Fire Hall #1, located adjacent to the existing City Hall, to see if it could be repurposed into a Transit Hub complete with public washrooms.

Partial funding for the Transit Hub is included in the approved 2023-2026 Capital Expenditure Program. Initial funding from the Investing in Canada Infrastructure Program (ICIP) has been secured with a Transfer Payment Agreement in place.

### **ALTERNATIVES**

- 1. Authorize Administration to commence the procurement for the downtown Transit Hub and amend the 2023 to 2026 Capital Expenditure Program as recommended; or
- 2. Refer project consideration back to Administration for further analysis.

### **ANALYSIS**

The consultant's review of the old Fire Hall #1 confirmed that the cost to upgrade would exceed the cost of demolishing the building and constructing new.

The current existing budget approved for the downtown Transit Hub is \$900,000. However, in order to demolish and replace the structure with a new Transit Hub complete with public washrooms, public waiting area, administrative space and food kiosk area, the new total budget for this project is anticipated to be \$2,800,000.

This project is eligible for funding through ICIP's Public Transit Stream, which the City typically uses to fund transit buses replacements and refurbishments. The City has also

submitted an application for Rural Transit Solution Fund, which if successful, would allow ICIP funding to be potentially reallocated to other City projects. Administration anticipates the complete project will be covered by external grant funding.

#### PURCHASING

An RFP will be issued publicly. The contract will be evaluated and awarded based on a combination of technical and organizational competence, price, and local context. The lowest-priced proposal is not guaranteed to be awarded the contract.

#### **Procurement Policy Principles**

**Compliance:** The RFP will follow City policy and procedures for procurements.

**Supplier Access, Transparency, and Fairness:** The RFP will be publicly available on the City's e-procurement platform, www.whitehorse.bonfirehub.ca

**Best Value:** The RFP will be publicly advertised and awarded to the lowest compliant bidder that can meet the specifications set by the City.

**Efficient and Effective Procurement:** The procurement of construction services for vertical infrastructure has been successfully completed numerous times by the City.

Local Procurement: Local contracting expertise is known to exist for this type of work.

**Sustainable Procurement:** A new heating system will be required for this project with the primary focus being on energy efficient and limited fossil fuel usage. This system may be shared with the new City Hall heating unit.

WHEREAS Section 238 of the *Municipal Act* (R.S.Y. 2002) provides that Council shall by bylaw adopt an Annual Operating Budget and a multi-year Capital Expenditure Program; and

WHEREAS Section 241 of the *Municipal Act* provides that no expenditure shall be made which increases total expenditures above what was approved in the Annual Operating Budget or the Capital Budget unless such expenditure is approved by bylaw; and

WHEREAS it has become necessary to increase the 2023 Capital Budget to provide for funding approved associated with the Transit Hub;

NOW THEREFORE the Council of the Municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- 1. The 2023 to 2026 Capital Expenditure Program is hereby amended by increasing the 2023 Capital Budget in the amount of \$1,900,000 to provide additional approved funding for the Transit Hub project.
- 2. This bylaw shall come into full force and effect upon final passing thereof.

### <u>ISSUE</u>

Council approval for the commencement of the procurement for design and construction of the City Hall Energy Efficiencies project.

### **REFERENCE**

- Procurement Policy 2020-03

### <u>HISTORY</u>

In accordance with Section 3.1.1 of the Procurement Policy, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more and of procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest. This procurement is anticipated to be over \$500,000.

In early 2022, Administration released a Request for Tender (RFT) for the construction of the all-in-one administration building at City Hall. The City subsequently cancelled the tender as the low bid was 35% over the approved budget.

Throughout the remainder of 2022 and early into 2023 Administration worked with a consultant to conduct a feasibility study to upgrade the building envelope and other energy efficiencies to the existing City Hall and to produce a Class D estimate of the potential renovation and upgrade costs.

Funding for the City Hall Energy Efficiencies project is included in the approved 2023-2026 Capital Expenditure Program. Small Communities Funds (SCF) are secured and a Transfer Payment Agreement is in place for this portion of the project with the remainder budgeted to come from City reserves.

### **ALTERNATIVES**

- 1. Authorize Administration to commence the procurement for the City Hall Energy Efficiencies; or
- 2. Refer project consideration back to Administration for further analysis.

### **ANALYSIS**

Recommendations from the consultant with respect to City Hall indicated that the energy efficiencies as well as the building structural improvements can be realized particularly for the 1967 portion of the existing facility.

The total approved budget for project 360c00823 is \$8,390,000.

#### PURCHASING

An RFP will be issued publicly. The contract will be evaluated and awarded based on a combination of technical and organizational competence, price, and local context. The lowest-priced proposal is not guaranteed to be awarded the contract.

#### **Procurement Policy Principles**

**Compliance:** The RFP will follow City policy and procedures for procurements.

**Supplier Access, Transparency, and Fairness:** The RFP will be publicly available on the City's e-procurement platform, www.whitehorse.bonfirehub.ca

**Best Value:** The RFP will be publicly advertised and awarded to the lowest compliant bidder that can meet the specifications set by the City.

**Efficient and Effective Procurement:** The procurement of construction services for vertical infrastructure has been successfully completed numerous times by the City.

Local Procurement: Local contracting expertise is known to exist for this type of work.

**Sustainable Procurement:** A new heating system will be required for this project with the primary focus being on energy efficient and limited fossil fuel usage.

#### <u>ISSUE</u>

A budget amendment is needed for the Range Road and McIntyre Creek Crossing Repair to address a portion of the retaining wall and water chamber that are failing.

#### **REFERENCE**

- 2023 to 2026 Capital Expenditure Plan
- Procurement Policy 2020-03

#### <u>HISTORY</u>

During routine inspections in the spring of 2023, City crews discovered localized failure of the gabion basket wall (the caged rock retaining wall) and a water chamber at the Range Road and McIntyre Creek crossing. This crossing was installed in 2011 as part of the construction of the Whistle Bend watermain supply line project. This spring, an inspection noted that there was significant erosion and scouring that resulted in the failure of the gabion basket wall. The cause of the infrastructure failure is currently under investigation. Urgent repairs are required in the short term to stabilize the retaining wall and reposition the water chamber to protect the surrounding infrastructure.

### **ALTERNATIVES**

- 1. Amend the 2023-2026 Capital Expenditure Plan and approve a new capital project for construction services for Range Road and McIntyre Creek Crossing Repair; or
- 2. Refer the matter back to Administration for further analysis.

### **ANALYSIS**

Repairs to the retaining wall and water chamber are required immediately to address the infrastructure failure.

The repair to the water chamber consists of removing the existing chamber, sub-cutting the underlying soils and rebuilding the foundation with drainage rock. With respect to the retaining wall, the erosion and scouring has accelerated this spring to the point that the wall has failed in one location.

Until the root cause of the infrastructure failure can be determined, Administration recommends an interim repair that consists of the placement of oversized rocks placed against the existing wall to add additional support to the existing wall. This is a low cost repair that will allow Administration to assess and plan for a more robust improvement in the future.

If this work is not completed at this time, there is a high risk that the earth embankment for Range Road could be compromised, resulting in impacts to the roadway structure. Additionally, without the interim repairs, it is likely that the retaining wall would continue to deteriorate rapidly and eliminate the opportunity to do a short term, low-cost repair and instead a full replacement would likely be required within a short timeframe. Additional assessment and engineering design will be required within the next few years.

An emergency procurement, as per the Procurement Policy, was initiated to commence the repair. Construction has started. These expenditures now need budgetary authority.

#### **ADMINISTRATIVE RECOMMENDATION**

THAT Council amend the 2023-2026 Capital Expenditure Plan and approve the creation of a new capital project for Range Road and McIntyre Creek Crossing Repair in the amount of \$100,000, funded by the Capital Reserve.
