<u>ISSUE</u>

An amendment is required to update the City's Snow and Ice Control Policy which designates winter maintenance priorities and service levels.

<u>HISTORY</u>

The Snow and Ice Control Policy identifies the City's winter maintenance operations and establishes the priorities and service levels for snow and ice control activities. The policy was last updated in October of 2022 and is reviewed annually.

ALTERNATIVES

- 1. Approve amendments to the Snow and Ice Control Policy Appendices; or
- 2. Refer the matter back to Administration for further analysis.

ANALYSIS

As a result of the completion of key capital and development projects, an amendment to the priorities and services levels as defined in the Snow and Ice Control Policy is required. More specifically, updates are needed to:

- Change Chilkoot Way to Priority 1 to accommodate the recently added protected "Greenway" bike lane. This change would have both the protected bike lane and the portion of Chilkoot Way from Quartz Road to the base of Two Mile Hill included as Priority 1;
- Reflect the removal of the Whistle Bend snow storage site from active use as the Government of Yukon has not renewed the lease for the City to utilize that site;
- Reflect the addition of the roads in Whistle Bend Phases 6 and 8;
- Reflect the addition of new sidewalks adjacent to City owned property at the end of Cook and Wheeler Street, and in Whistle Bend; and
- Reflect the adjustment of Whitehorse Transit stops required for services as a result of the recent route changes that were implemented.

ADMINISTRATIVE RECOMMENDATION

THAT Council approve amendments, as proposed, to Appendix "A", "B" and "C" of the Snow and Ice Control policy.


SNOW & ICE CONTROL POLICY APPENDIX "C" SIDEWALK, TRANSIT STOPS & TRAILS - OCT 2023

<u>HISTORY</u>

Council policy governs the allocation of recreation grants. The Recreation Grant Task Force met on September 28, 2023 to discuss the applications and compile recommendations for funding in accordance with the Recreation Grant Policy.

A total of \$250,000 is available for two granting sessions in 2023. The funding available for this session for all Recreation Grant categories is \$85,000, plus any refunds received.

The total amount received by the City for 2023 through the Community Lottery Fund was \$197,176. The City continues to acknowledge Lotteries Yukon support in City advertising.

ALTERNATIVES

- 1. Approve the allocation of the grants as recommended by the Task Force; or
- 2. Refer the matter back to Administration.

ANALYSIS

The Recreation Grant Task Force received and reviewed seventeen applications totalling \$97,796.34 in requests. Applications were submitted under the Recreation Grant Policy and the four funding categories: Ongoing Projects and Initiatives, New Projects and Initiatives, Training and Leadership Development, and Operational Support.

The evaluation of the applications was conducted using the evaluation matrix and eligibility criteria.

Council has the authority to deny any of the recommendations brought forward by the Task Force. The result of denied recommendations is that some projects might not proceed.

Per the Community Lotteries guidelines, any requests that are related to operations & maintenance (O&M) are ineligible for funding. This means that all O&M requests received are funded using the City's contribution of \$52,824.

A summary of applications received, together with the recommendations of the Task Force, are listed in the attached documents identified as Appendix A – Grant Summary and Appendix B – Operational Support Summary.

Approval of \$84,896.34 is recommended for allocation by the Recreation Grant Task Force and is within the amount of funding available.

Where funding recommendations do not reflect the full amount of funding requests, it is because certain elements of an application may be fundable under another program, it is reflective of the condition of the application, or there are insufficient grant funds to fully cover the request.

ADMINISTRATIVE RECOMMENDATION

THAT Council approve the allocation of \$84,896.34 for Recreation Grants as recommended by the Recreation Grant Task Force.

Application for Conditional Use approval to allow a 136 m² caretaker suite located at 22 Metropolit Lane (Lot 1160-1, Quad 105D/11, 96773 CLSR YT).

<u>HISTORY</u>

The property located at 22 Metropolit Lane is currently used by Yukon Gardens as a nursery area for their landscaping business, permitted as General Contractor Services in the Zoning Bylaw. The owner and operator of Yukon Gardens has applied for a 136 m² caretaker residence on this property. There are currently no permitted structures on the property. The Zoning Bylaw allows caretaker residences up to 120 m² as a principal use and lists caretaker residences 121 m² to 297 m² in size as a conditional use, which Council can approve at their discretion. The proposed new structure proposes the 136 m² caretaker suite on the second storey and an office lunchroom and garage/shop on the ground floor.

ANALYSIS

Zoning Bylaw

The current zoning for the subject property is CIMx(f), Mixed Use Commercial/ Industrial. The purpose of the CIM zone is to provide a mix of commercial and industrial uses. The zoning bylaw allows caretaker residences between 121 m² and 297 m² as a conditional use, which Council can approve at their discretion.

Section 4.9.5 of the Zoning Bylaw provides criteria for Council to consider when evaluating a conditional use application. These criteria include:

Design and Character: The building design and function of the lot is not out of character with other buildings in this neighbourhood.


Parking and traffic: The building is set back from Metropolit Lane on a larger lot (3,898 m²) providing adequate parking on-site. The proposed conditional use will not generate traffic outside the normal expectations of the neighbourhood.


Impact on neighbouring properties: The use of caretaker suites was established to allow businesses to provide 24-hour security over their lots. The maximum size was established to act as an impediment to family uses in areas of town where residential use isn't planned and where nearby, adjacent commercial or industrial uses may impact on neighbouring properties by way of noise, odor, smoke, light, or vibration.

Strategic Priorities: This caretaker suite meets the identified strategic priority to improve the overall housing supply in Whitehorse through creating the ability for businesses to add staff housing on commercial and industrial lands.

PUBLIC INPUT SESSION SCHEDULED

In accordance with section 4.8 of Zoning Bylaw 2012-20, a public input session has been scheduled for the Council meeting on October 23, 2023. Government of Yukon, Kwanlin Dün First Nation and the Ta'an Kwäch'än Council were notified by mail and email. A notice of the proposed development was placed in local newspapers on September 29, 2023.









