#### **HISTORY**

In accordance with section 3.5.2 of the Procurement Policy, Administration is required to provide publicly to Council a semi-annual update on procurement projects, including:

- Contract awards with a value of \$100,000 and over;
- Procurements with a value of over \$100,000 that have incorporated requirements related to economic, social and/or environmental sustainability in their solicitation documents;
- Procurements for which authority has been delegated to the City Manager pursuant to section 3.1.2 of this policy;
- Non-Competitive, single source or sole source procurements with a value over \$50,000:
- Emergency procurements, including their value;
- Contract extensions or renewals where the original contract contains no option for renewal, describing how the extension or renewal conforms to the requirements of this policy; and
- Instances of non-compliance with the policy and ensuing actions taken in each instance.

#### **ANALYSIS**

Appendix A includes detailed listings of procurements for the second half of 2023 from July 1 to December 31, 2023 as required under the Procurement Policy. There were two procurement projects with values over \$100,000 that have incorporated requirements related to economic, social and/or environmental sustainability in the solicitation documents, namely, "Consulting services for re-writing Zoning Bylaw" and "Progressive design-build services for the Whitehorse Operations Building Administration Wing expansion". There were no procurements for which authority had been delegated to the City Manager, and no contract extensions/renewals where the original contract contained no option for renewal. There was no instance of non-compliance during this period of time.

Appendix A – 2023 Umbrella Grants Summary

#### **HISTORY**

Section 245 of the *Municipal Act* requires that grants provided to any person, institution, association or group be authorized by bylaw.

The City provides a variety of grants and donations to groups and organizations throughout the year. In 1996 Council adopted a process to facilitate the allocation of grants that allows grant funds to be initially approved by council resolution and subsequently authorized in an umbrella grant bylaw at year-end. This system allows the distribution of funds to qualified and approved applicants in a timely manner without the administrative and time delays that are part of the bylaw process.

#### **ANALYSIS**

Attached Appendix A provides a detailed listing of the grants approved according to Council policy and by Council resolution throughout 2023. They include:

- Community Clean-up Grants
- Development Incentive Grants
- Diversion Credit Grants
- Environmental Fund Grants

WHEREAS section 245 of the *Municipal Act* (R.S.Y. 2002) provides that council may by bylaw provide grants to any person, institution, association, group, government or body of any kind; and

WHEREAS in 1996 council adopted a process that approves a variety of grants by council resolution throughout the year and subsequently authorizes these grants by way of an umbrella bylaw at year end;

NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- Community Clean-up Grants, Development Incentive Grants, Diversion Credit Grants, Environmental Fund Grants, Festival and Special Event Grants, Miscellaneous Donations and Grants, Recreation Grants, and Youth Recreation Programming Grants are hereby authorized as outlined in Appendix "A" attached hereto and forming part of this bylaw.
- 2. Council may by resolution withhold the payment of any grant authorized under section 1 of this bylaw if the recipient fails to adhere to any terms and conditions determined by council.
- 3. This bylaw shall come into full force and effect upon the final passing thereof.

Council approval to commence the procurement of Street Sweepers.

## <u>REFERENCE</u>

Procurement Policy 2020-03

2024-2027 Capital Expenditure Program projects 320c00922 and 320c01209

## **HISTORY**

In accordance with Section 3.1.1 of the Procurement Policy, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more and of procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest.

Funding for two Street Sweepers is included in the approved 2024 Capital Expenditure Plan. One procurement is planned for these two units with an estimated value greater than \$500,000. The 2024 Capital Expenditure Plan (projects 320c00922 and 320c01209) includes funding for two street sweepers with a total budget of \$1,130,000. These pieces of equipment are integral to the City's road maintenance programs.

#### **ALTERNATIVES**

- 1. Authorize Administration to commence the procurement for 2 street sweepers; or
- 2. Refer the matter back to Administration.

#### **ANALYSIS**

This 2024 procurement is being advanced without delay due to current long lead times for equipment, industry supply issues, and volatility in equipment pricing. Based on the latest industry feedback, it is anticipated that the lead-time for this equipment will be approximately twelve months from date of order/award.

## <u>Purchasing</u>

A Request for Tender (RFT) will be publicly issued and the lowest compliant bid will be eligible for contract award. Purchase approval will be obtained in accordance with the Procurement Policy.

**Compliance:** The RFT will follow City policy and procedures for procurements.

## **ISSUE**

Council approval to re-budget capital funds and to commence the procurement for the desludging of Cell A of the Livingstone Trail Environmental Control Facility (LTECF).

#### **HISTORY**

In accordance with Section 3.1.1 of the Procurement Policy, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more and of procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest. This project is anticipated to be over \$500,000.

The City of Whitehorse operates the LTECF as its main wastewater treatment facility. The removal of the settled biosolids from the LTECF primary cells is performed periodically to upkeep the performance of the facultative system. The overall performance of the facility is monitored and regulated by the City's Water License MN20-008-01. The Sludge Management Plan under the WUL, specify the desludging frequency of the primary cells. The scheduled time for Cell A was 2022, however, contractors could not be retained to empty the sludge drying bed. The sludge transfer was not completed until August 2023.

This project will seek hiring a contractor for the removal of settled biosolids by dredging the Cell A of the LTECF, and transfer into contractor-supplied geotubes.

Budget for this project is included in the approved 2023 – 2026 Capital Expenditure Program under 650c00321 Livingstone Lagoon Desludging and is fully funded by the Canada Community Building Fund (CCBF). Of the \$898,543 budgeted in 2023, \$163,208 has been spent and the remaining \$735,335 is eligible to be carried forward to 2024 through the City's re-budget process. As capital re-budgets are not normally brought forward until March, Council is asked to re-budget this project in advance in order to allow the procurement to proceed.

#### **ALTERNATIVES**

- Re-budget the remaining budget for the Livingstone Lagoon Desludging project to 2024, and authorize Administration to commence the procurement for the project; or
- 2. Refer the matter back to Administration.

## **ANALYSIS**

The municipal wastewater contains both organic and inorganic solids. The solids settle in the primary cells, as wastewater reaches the LTECF. The organic solids may break down by anaerobic microorganisms at the bottom of the cells. However, the inorganic (non-biodegradable) solids remain. The primary cells have room for solids to accumulate at the bottom, however, it is not recommended for the solids to over-accumulate, as the primary cells would lose sedimentation capacity, and the solids would overflow into the secondary cells. This overflow would decrease treatment efficiency.

The execution of this work is part of a comprehensive group of tasks and projects performed to fulfil the City's Water License requirements. A high amount of work is conducted in and around the LTECF, both using in-house personnel and contractors. The Water Monitoring Program is an important project performed by contractors. This desludging project is another project performed by contractors, as its execution requires specialized equipment and operators.

## Purchasing

A Request for Tender (RFT) will be publicly issued and the lowest compliant bid will be eligible for contract award. Purchase approval will be obtained in accordance with the Procurement Policy.

## **ANALYSIS**

## The Arctic Urban & Regional Cooperation (AURC)

AURC is a new international programme that emphasizes peer learning and collaboration among Arctic cities, towns, and local authorities. The program aims to address challenges related to sustainable development in the region, particularly climate change and environmental protection. The knowledge exchange occurs through webinars, study visits, and thematic networking events.

As part of the program, the Mayor has been invited to attend the inaugural meeting taking place during Arctic Frontiers 2024 in Tromsø, Norway from January 29 to January 31, 2024. The Arctic Frontiers Annual Conference is a platform that brings together diverse expertise from science, business, policy, and indigenous communities. It aims to facilitate networking, knowledge sharing, and discussions on pressing Arctic issues, such as climate change mitigation and energy transition. Travel and attendance costs are covered by the AURC, and any incidental costs incurred are expected to be well within the Mayor's 2024 travel budget allocation.

The City submitted a project proposal centered on enhancing community resilience in emergencies such as forest fires and floods. The focus is on cultivating a robust community capable of handling potential disasters through preparedness, response, and recovery. Importantly, the emphasis is on social and cultural resilience rather than solely on emergency services management. The submission also included exploration and observations of electric transportation solutions in the arctic, as well as storm preparedness as it relates to engineering standards to ensure short and long-term infrastructure capabilities.

Notable attendees include the Mayors of Yellowknife, NWT, Utqiagvik, AK, and Fairbanks North Star Borough, along with representatives from Sweden, Finland, Norway, Iceland, and Greenland. Each participating community has submitted projects to either learn or gain experiences from the program.

The City is expected to actively engage in webinars, workshops, and knowledge-sharing sessions, both offering local insights and receiving feedback from other participating communities. For example, a webinar may offer AURC participants the opportunity to learn about a participating City's diverse economic and socio-economic context and challenges related to sustainable development and the innovative strategies and initiatives that they are undertaking.

## **Arctic Winter Games (AWG)**

The Mayor has been invited to attend the Mat-Su 2024 Arctic Winter Games in Alaska. As the Mayor of the next host City, participation is required to facilitate the transfer of valuable knowledge, meet with stakeholders, and mark the official handoff to the City of Whitehorse. This opportunity also serves as a platform for the City of Whitehorse to be represented, observe the Games in action, and showcase its commitment and involvement within the Arctic Winter Games community. Costs incurred are expected to be well within Mayor's 2024 travel budget allocation.

## **ADMINISTRATIVE RECOMMENDATION**

THAT travel expenses beyond those covered by AURC and AWG be authorized for Mayor Cabott to attend Arctic Frontiers, January 27 to February 2, 2024 and Arctic Winter Games March 13 to 16, 2024.

#### **HISTORY**

An application was received to rezone 2086 Second Avenue from CM2 – Mixed Use Commercial 2 to CM2x – Mixed Use Commercial 2 (modified) to allow for the development of a mixed use building up to a maximum height of 25 m. The proposed building is six storeys with retail services on the ground floor and offices above. The applicant is seeking a special modification due to the recent adoption of the Official Community Plan (OCP) which allows greater heights in the Downtown.

On May 17, 2023, the rezoning application was reviewed by the Development Review Committee (DRC). DRC recommended that wilderness views are protected and that the proposal must align with the recently adopted OCP. Following DRC, Administration worked with the applicant to ensure DRC concerns were addressed as detailed in the Analysis.

## **ANALYSIS**

#### **Site Context**

The subject site is located on Second Avenue between Hanson Street and Lambert Street in Downtown. The area to the south and west of the subject site is also zoned CM2 and the area to the north is zoned CC – Core Commercial. To the east is the Whitehorse Visitor Information Centre and the Government of Yukon Jim Smith Building which are zoned PS – Public Services. The buildings in the surrounding area are between one to four storeys with a mixture of office, commercial, institutional, and residential uses.

## 2040 Official Community Plan

The subject site is designated as Mixed Use – Downtown Core in the OCP. The OCP seeks to increase Downtown building heights. OCP policy 15.8.7 states that the maximum building height in the Mixed Use – Downtown Core designation is 25 m, however buildings up to 30 m may be considered. The OCP policy allows for buildings up to 25 m across the Mixed Use – Downtown Core area. The special modification is to allow for a maximum building height of 25 m on the subject site.

## **Zoning Bylaw**

The purpose of the CM2 zone is to provide for a mix of low intensity commercial and residential uses for the transitional area around the periphery of the downtown commercial core. The CM2 zone allows for many principal uses including offices and retail services.

Appendix C of the Zoning Bylaw provides maximum building heights for Downtown areas. The subject site and the surrounding area has a maximum building height of 20 m. The definition of building height excludes several features which may extend beyond the height limit, such as roof stairway entrances, elevator housing, and ventilation equipment.

## Impacts: Shadows, Massing, and Wind

## **Shadows**

The applicant provided a shadow analysis to better understand the shadow impacts of a 25 m building compared to a 20 m building on the surrounding properties.

To the west of the subject site, at 206 Hanson Street, a 25 m building would cast a shadow for up to an extra 30 minutes in the fall and three hours in late spring/summer. There would be no additional days that a shadow would be cast on 206 Hanson Street.

To the east of the subject site, at the Whitehorse Visitor Information Centre, a 25 m building would cast a shadow for up to an extra 30 minutes in the fall and spring and three hours in winter. A shadow would also be cast on the Information Centre for an additional five days in spring and five days in fall.

To the north of the subject site, at 2090 Second Avenue, a 25 m building would cast a shadow for up to an extra 30 minutes in the fall and two hours in winter. A shadow would also be cast on the building for an additional five days in spring and five days in fall.

## Massing

The CM2 zone requires no front, side, or rear yard setbacks. For portions of buildings greater than 20 m in height and built at zero setback, upper floors are required to be setback at least 2 m from property lines in an attempt to hide the addition height from view at street level. The CM2 zone also allows a building to occupy up to 90% of the lot.

## Wind


Tall buildings can have impacts on wind however the impacts can be reduced in various ways. Winter city design principles in the Zoning Bylaw apply to this development and include reducing wind impacts through landscaping and design.

#### 2018 Downtown Plan

The subject site is located within the study area of the Downtown Plan. Policy 6.3.7 states that Downtown should retain its focus as the primary employment area by directing traditional office development primarily into the Downtown Core Commercial (CC) and Mixed Use Commercial (CM1 and CM2) zones. The proposed amendment is in alignment with this policy as it enables a greater concentration of commercial uses within the CM2 zone, which will further support the Downtown as a primary employment area.

## ADMINISTRATIVE RECOMMENDATION

THAT Council direct that Bylaw 2024-09, a bylaw to amend the zoning at 2086 Second Avenue to allow for the development of a building with a maximum height of 25 m, be brought forward for consideration under the bylaw process.





## **HISTORY**

The lands at 3 and 5 Garden Road are currently vacant and the City has never issued a development permit or building permit on these properties. The properties were originally subdivided out of the larger Yukon Gardens parcel in 2010 with the 5 Garden Road property having been re-subdivided again in 2013 to create an enlarged lot. The Yukon Employees Union (YEU) and the Public Service Alliance of Canada (PSAC) have an agreement to purchase these two properties contingent on this Conditional Use application being approved. They have applied for a development permit for a single storey 1,283 m² office complex on the consolidated property.

## **ANALYSIS**

## **Zoning Bylaw**

The current zoning for these properties is CH - Highway Commercial. The stated purpose of the CH zone is "to provide a zone for high quality commercial development primarily along arterial roadways including those that serve as entrance and tourist routes into the City." The Zoning Bylaw does not have 'offices' as a listed principal use in the CH zone, but does list 'offices above the ground floor' as a secondary use in the CH zone. Note that a secondary use must be in conjunction with and subordinate to a listed, permitted principal use. The proposed use cannot be approved as a secondary use because the

building proposed only has one storey and the office use proposed would be the primary use, not connected to any listed primary principal use. The Zoning Bylaw does allow for a principal use of 'offices on the ground floor' as a conditional use which Council can approve at their discretion.

The Zoning Bylaw defines 'offices' as "the use of premises for professional, management, administrative, consulting, and financial services in an office setting. Typical uses include the offices of lawyers, accountants, real estate and insurance firms, clerical, secretarial, banks, doctors, dentists, and government agencies."

The YEU and PSAC are union bodies and their offices are the primary union access points. The proposed building will serve as office space for staff and clients and provide meeting space for their membership.

Section 4.9.5 of the Zoning Bylaw provides criteria for Council to consider when evaluating a conditional use application. These criteria include:

**Design and Character:** The building design and function of the lot is not out of character with other buildings in this neighbourhood.

**Parking and traffic:** The proposed site plan provides the required number of parking spaces for office use based on the amount of gross floor area of the proposed building.


**Capacity of Infrastructure:** The proposal has been reviewed by Engineering Services and deemed to meet relevant guidelines and bylaws.

**Impact on neighbouring properties:** Typically office use does not produce effects that may impact neighbouring properties such as noise, odour, smoke, light, or vibration. The establishment of the commercial use will increase traffic as anticipated when the neighbourhood subdivision was first reviewed and approved.

**Plans and Policies:** The Official Community Plan (OCP) designates this land industrial/commercial which is intended to accommodate a mix of light industrial and caroriented commercial uses that occur primarily within enclosed buildings. The OCP also identifies a need for additional Industrial/Commercial land within the City boundary.

## PUBLIC INPUT SESSION SCHEDULED

In accordance with section 4.8 of Zoning Bylaw 2012-20, a public input session has been scheduled for the regular council meeting on January 15, 2024. Government of Yukon, Kwanlin Dün First Nation and the Ta'an Kwäch'än Council were notified by e-mail. A notice of the proposed development was placed in local newspapers on December 15, 2023.
