#### **DELEGATE SUBMISSIONS**

Delegates Lianne Maitland and Maggie Leary, representing the Yukon Historical Museums Association, spoke in support of the proposed Heritage Fund Grant for the 2025 Yukon/Stikine Regional Heritage Fair. The delegates provided information about the event and extended an invitation to the members of Council to attend on May 1 at the Kwanlin Dün Cultural Centre.

Delegate Bree Pepper spoke in opposition to the proposed Traffic Bylaw amendment to increase parking infraction fines, stating the negative impact it would have on downtown businesses. The delegate explained that the proposed amendments will deter clients and put additional burden on employees.

As requested by Committee members, Administration provided information on current regulations and processes for mining within the city under YESAB requirements, the Quartz Mining Act, the Zoning Bylaw, and the Official Community Plan, and the responsibilities and jurisdiction of the municipal government. Administration also responded to concerns regarding noise levels and water monitoring.

Delegate Skeeter Wright requested that Council take initiative to amend the Zoning Amendment and Official Community Plan to restrict mining in Whitehorse, noting that federal and territorial legislation does not allow for Council's discretion per application. The delegate clarified that Council could direct that an amendment to the Zoning Bylaw and Official Community Plan be brought forward to restrict that the possibility of mining in the city.

Delegate Skeeter Wright -Mining in the City

New Business - Mining in the

Delegate Don Roberts of Yukoners Concerned spoke to Council in support of restricting mining in Whitehorse through the bylaw process. The delegate noted the effect mining has on the environment and residents, and described the problems caused by previous mining efforts.

Delegate Angela Sabo presented to Council about the effects of mining exploration activities on municipal and domestic water wells, and on the role drilling plays in accelerating permafrost thawing. As requested, the delegate also recommended an ongoing study for Council to monitor for the most up-to-date research on mining.

Delegate Glenys Baltimore urged Council to restrict further mining exploration and drilling, sharing the negative experiences of residents due to entry level exploration. The delegate noted concerns for domestic water wells, recreation, wildlife, and the health of residents.

Delegate Glenys Baltimore – Mining in the City

Delegate Sibell Hackney raised concerns about large and noisy machinery destroying local trails and wildlife habitat, and disturbing nearby residents. The delegate urged Council to prioritize the wilderness that Whitehorse citizens take pride in.

Delegate Stephen Burles requested that Council listen carefully to residents, noting that the increase in noise, dust, and traffic levels caused by mining activities most negatively impacts citizens that live nearby. The delegate urged Council to restrict mining completely from city limits.

Delegate Stephen Burles – Mining in the City

Delegate Tory Russell, representing Yukoners Concerned, spoke to Council on the dangers mining activities pose to municipal and domestic water wells, and to the Yukon River. The delegate argued that the current legislative approach to mining within Whitehorse does not respect the Umbrella Final Agreement or Whitehorse residents and urged Council to restrict mining from the city until mining legislation is modernized and made fair.

Delegate Tory Russell, Yukoners Concerned – Mining in the City

Delegate Spence Hill raised concerns about the future of Whitehorse due to slow progress in updating territorial mining legislation and subsequent irresponsible mining. The delegate urged Council to restrict mining from the city until it can be done in a way that is safe and respectful to the land, the wildlife, and the people of Whitehorse.

Delegate Spence Hill – Mining in the City Delegate Jonas Smith, Executive Director of the Yukon Chamber of Mines, presented in support of Council focusing on matters more specific to their scope of responsibility and keeping municipal mining limitations as they are. The delegate stated that the Yukon has some of the highest environmental and safety standards in the world, and that mining has brought positive impacts to Whitehorse and many of its citizens.

#### 1. Heritage Restoration Incentive Application – Hulland House

A Heritage Restoration Incentive application was received and presented for the restoration of the Hulland House located at 704 Wood Street, a property designated as a Municipal Historic Site for its association with Jack Hulland. If approved, the funding will support both exterior and structural restoration, helping maintain the site and its representation of early Whitehorse architecture. As requested, Administration provided additional information on the fund, the history of the property, and the Heritage Registry.

#### The Recommendation of the City Planning Committee is

THAT Council allocate \$20,000.00 from the Heritage Fund to assist with restoration costs for the Hulland House.

#### 2. New Business – Addressing Homelessness

As requested by Committee members, Administration provided information on the City's involvement in updating the 2017 Plan to End Homelessness and on communications with other government and non-government agencies. A history of efforts made by the City to end and prevent homelessness in Whitehorse was shared, along with ongoing, upcoming, and potential initiatives.

### 3. <u>Delegates Maddie Porter and Kristina Craig, Yukon Anti-Poverty Coalition – Revising the 2017 Plan to End Homelessness</u>

Delegates Maddie Porter and Kristina Craig, representing the Yukon Anti-Poverty Coalition (YAPC), presented the planning process, timeline, and targets outlined to work towards ending homelessness in the community. A report was presented outlining a Voluntary Financing Program (VFP/LIC) for Hillcrest residents to have their private-side water and sewer services replaced with municipal services as part of the City's reconstruction project that 5 residents have opted in to. Alongside the proposed VFP/LIC bylaw, amendments to the Infrastructure Replacement and Local Improvement Policy were also proposed to improve language and allow administrative flexibility for future programs. As requested, Administration responded to questions about funding for the program, the benefits and drawbacks of participating, communication methods, and on projected timelines for the reconstruction.

**Re**: Motion – Standard Building Design Guides (Amended)

I, Councillor Dan Boyd, having given notice at the Standing Committee held April 7, 2025, now move as follows:

WHEREAS the National Building Code of Canada requires an increasing amount of engineering; and

WHEREAS engineering costs contribute to the cost of housing and development; and

WHEREAS in other jurisdictions, provincial governments often provide developers with guides for standard building designs; and

WHEREAS Yukoners would benefit from access to guides in order to build within Part 9 of the National Building Code for common and/or simple aspects of building plans;

THEREFORE, BE IT RESOLVED THAT Administration be directed to bring forward a Budget Amendment in an amount not to exceed \$50,000 for the purpose of producing guides to be made available to the public; guides may include items such as ledger boards for exterior decks, snow stops on metal roofing, nine-foot walls on Permanent Wood Foundations and tall walls.

A bylaw to provide for a Voluntary Financing Program/Local Improvement Charge for the Hillcrest Reconstruction Project Phase 1A

WHEREAS section 267(1) of the *Municipal Act* (R.S.Y. 2002) provides that a municipality may undertake any local improvement it considers necessary for the benefit of all or part of a municipality; and

WHEREAS section 268 of the *Municipal Act* provides that Council may, by bylaw, prescribe the parcels of land benefiting from the local improvement and levy all or a portion of the cost of the improvement against those parcels, and provide for the means of assessment, collection, and payment of that cost; and

WHEREAS the Infrastructure Reconstruction and Local Improvement Policy adopted by Council in 2021 provides that infrastructure work on private property may be undertaken at the property owner's request, and

WHEREAS an amendment has been made to the Infrastructure Reconstruction and Local Improvement Policy to allow the Voluntary Financing Program to be applied as a local improvement charge to recover associated costs; and

WHEREAS the City has initiated Phase 1A of the Hillcrest Reconstruction Project to replace aging water, sewer, and roadway infrastructure, and has offered affected property owners the opportunity to voluntarily participate in the renewal of private-side infrastructure, at their cost; and

WHEREAS certain property owners within the Phase 1A project area have opted in and entered into agreements with the City for the performance of private-side infrastructure work, and Council deems it expedient to recover the cost of such work by way of a local improvement charge;

WHEREAS in order to construct and complete the private-side portion of the project it will be necessary to borrow up to the sum of \$77,437.50 on the credit of the City by issuing debentures as herein provided; and

WHEREAS the amount of taxable assessment as last determined and fixed by the Assessment Review Board for 2024 was \$4,239,221,160; and

WHEREAS the amount of debenture debt of the City as at December 31, 2024 was \$12,365,539, no part of which is in arrears; and

WHEREAS the estimated life of the project exceeds fifteen years;

NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

#### Hillcrest Phase 1A Local Improvement Charges Bylaw 2025-22

- 1. Pursuant to section 269(1) of the *Municipal Act*, the City has notified all benefiting property owners abutting the reconstruction area as set out in Schedule "A" attached to and forming part of this bylaw.
- 2. The properties benefiting from the private-side upgrades who have agreed to participate in the City's Voluntary Financing Program in accordance with the provisions of City of Whitehorse Infrastructure Reconstruction and Local Improvement Policy are as set out in Schedule "A" to this bylaw.
- 3. The total cost of the private-side portion of the Hillcrest Phase 1A project has been determined in accordance with the provisions of the City of Whitehorse Infrastructure Reconstruction and Local Improvement Policy.
- 4. A private-side cost of the work is to be paid for by way of a tax to be levied on those properties as set out in Schedule "A" to this bylaw as a Local Improvement Charge.
- 5. The provisions of section 269 and 270 of the *Municipal Act* have been met as no objections to the private-side local improvements on the properties set out in Schedule "A" were received.
- 6. For the purposes aforesaid, the sum of up to \$77,437.50 is to be borrowed by way of debentures issued on the credit and security of the City at large.
- 7. The sum of \$77,437.50 is to be collected by way of a special assessment as provided in Schedule "A" to this bylaw.
- 8. The debentures to be issued under this bylaw shall be dated upon such day as may be appropriate having regard to the date of the borrowing and shall be issued for the term of 15 years. The said debentures shall be issued in such manner that the principal and interest will be combined and be made payable in, as nearly as possible, equal annual instalments during the said 15 years.
- 9. The debentures shall bear interest during the currency of the debenture at a rate not exceeding the rate as fixed from time to time by the Department of Finance of the Government of Yukon as being the rate of interest applicable on loans to municipalities and others.
- 10. The Mayor and Corporate Services shall sign the said debentures, and the corporate seal of the City shall be affixed.
- 11. There shall be levied and raised in each year of the local improvement hereby authorized the amount necessary to pay the annual amount of interest and principal falling due in each year on such debenture. The amount necessary shall be raised by levying a special assessment under the *Assessment and Taxation Act*, and there is hereby imposed on all lands set out in Schedule "A" attached hereto and forming part of this bylaw, an annual fee for each of 15 years. At the date of borrowing, the annual fee shall be computed based on the same interest rate as the borrowing allowed for in section 9 of this bylaw. The said special assessment shall be in addition to all other rates and taxes.

#### Hillcrest Phase 1A Local Improvement Charges Bylaw 2025-22

- (1) The property owner has the option of paying the total property charge prior to its due date, or of paying equal annual instalments each of 15 years, commencing on the due date.
- (2) The property owner may reduce the balance owing on the total property charge by making a lump sum payment in any year during the life of the bylaw. Such lump sum payments shall be accepted only in the month of January each year.
- (3) The property owner may pay off the balance owing at any point during the 15-year life of the bylaw.
- 12. The charge is determined based on estimates reviewed and accepted by the property owners and shall not exceed the total estimate agreed to by both the City of Whitehorse and the property owners at the time of the agreement.
