## **DELEGATE SUBMISSIONS**

Liz Reichenbach spoke in opposition to allowing snowmobile access on non-motorized trails in the McPherson and Hidden Valley areas. The delegate questioned the accuracy of survey results used to justify the plan, recommended stronger bylaw enforcement and trail education, and urged Council to either reject or delay the proposed trail plan to allow for more informed public input.

Mayor Cameron advised that a Public Hearing was scheduled at this meeting to hear any submissions with respect to the Zoning Amendment related to 10 Eldorado Drive.

Zoning Amendment – 10 Eldorado Drive

Administration confirmed that at least 3 written submissions were received on this item, all in support.

Mayor Cameron advised that a Public Hearing was scheduled at this meeting to hear any submissions with respect to the proposed Zoning Amendment at 14 Tarahne Way.

Zoning Amendment – 14 Tarahne Way

Administration confirmed that at least 14 written submissions were received on this item, with 9 in opposition and 5 in support.

Written Submissions

Mayor Cameron called three times for submissions with respect to the proposed Zoning Amendment at 14 Tarahne Way.

Zoning Amendment – 14 Tarahne Way

Maija Pumphrey spoke in support of new amenities in Whistle Bend but opposed the proposed drive-through, citing concerns that it contradicts the City's Sustainability Plan by increasing greenhouse gas emissions, promoting unhealthy lifestyles, generating additional waste, and reducing walkability and community connection. It was noted that drive-throughs often benefit franchises over local businesses and may limit opportunities for a more inclusive, locally based food economy.

Maija Pumphrey

Tiara Topps spoke in strong opposition to the proposed drivethrough, stating it contradicts the Whistle Bend Master Plan and City sustainability goals. Concerns included increased traffic, safety risks, environmental impacts, noise, reduced property values, and negative health outcomes. It was noted that a drive-through may limit access to a sit-down community hub for residents with mobility challenges.

Tiara Topps

Megan Foreman and Chris Shelley, on behalf of Northern Vision Development, spoke in support of the proposed zoning amendment, stating the development would provide essential services for Whistle Bend residents, reduce travel downtown, and support a complete, livable community. The speakers noted a drive-through could improve viability by helping attract long-term tenants, though no final decision has been made. Civil works could begin next summer, with construction expected in the fall.

After being duly moved and seconded, the decision to approve or not approve the Whitehorse North Trail Plan as a guiding document was postponed to the August 11, 2025 Regular Council meeting.

Motion to Postpone – Whitehorse North Trail Plan

Delegates Michael Grooms and Arwen Rowe-Duguay spoke to Council, raising concerns about the shift to a lottery-based preschool registration system at the Canada Games Centre. They emphasized the importance of continuity in early childhood programming and highlighted the lack of notice, consultation, and communication around the change. In response to Council questions, the delegates confirmed families were notified shortly before registration opened and that City staff were presented with alternative options.

Delegate Michael Grooms and Arwen Rowe-Duguay – CGC Preschool Registration Changes

Delegate Anthony Bier, representing the Contagious Mountain Bike Club, spoke to Council in support of two trail development applications meant to improve safety, rider experience, winter access, as well as reduce user conflicts. In response to Council questions, the delegate explained the concept of a pump track and outlined the Club's maintenance agreement with the City.

Delegate Brad Halt, a resident of Takhini North, spoke to Council in support of the Amanda Taylor Memorial Connector, sharing that the trail is intended to honour a dedicated community member and former Contagious Mountain Bike Club board member who passed away in 2022. The proposed 900-metre trail would connect two sections of the Mount McIntyre trail network and was developed in collaboration with local trail users and organizations.

Delegate Keith Lay, speaking as an associate of Active Trails Whitehorse Association, urged Council to refer the Whitehorse North Trail Plan back to administration for further consideration. In response to Council questions, the delegate clarified their role with the association, spoke to past commitments made through the 2020 Trail Plan to develop neighbourhood trail plans using charrettes, and emphasized the importance of transparency and community-driven planning.

## 1. Public Hearing Report - Zoning Amendment - 10 Eldorado Drive

The Committee was presented with a summary of the Public Hearing held on July 7, 2025, regarding the proposed Zoning Amendment to allow for the development of a 1.8m high fence to provide security for the temporary shelter at 10 Eldorado Drive. Three written submissions were received in support, and no one spoke at the Public Hearing. Because the support received was based on the nature of the facility, the report recommended amending the bylaw to only allow the 1.8m high fence for a temporary shelter.

## The Recommendation of the City Planning Committee is

THAT Council direct that Bylaw 2025-27, a bylaw to amend the zoning of 10 Eldorado Drive from PS – Public Service to PSx(f) – Public Service (modified), be amended to only apply to a temporary shelter use, and be brought forward at second and third reading under the bylaw process.

## 2. Public Hearing Report - Zoning Amendment – 14 Tarahne Way

The Committee received a summary of the July 7, 2025, Public Hearing on the proposed Zoning Amendment for a drive-through eating and drinking establishment at 14 Tarahne Way. Of nineteen written submissions, five supported the proposal and 14 opposed it. Three people spoke at the Public Hearing – two spoke in opposition, one of whom also submitted in writing, and the proponent of the application. The report addressed concerns about neighbourhood character, health impacts, traffic, vehicle idling, and local economic development, and proposed revisions to the bylaw to improve neighbourhood compatibility. As requested, Administration expanded on the litter and traffic capacity concerns, comparable past amendments, and the environmental impact of current drive-throughs in Whitehorse.

## The Recommendation of the City Planning Committee is

THAT Council direct that Bylaw 2025-29, a bylaw to amend the zoning of 14 Tarahne Way, from CNC – Comprehensive Neighbourhood Commercial to CNCx(d) – Comprehensive Neighbourhood Commercial (modified), be amended to include additional requirements and restrictions that support active transportation and mitigate negative effects caused by idling vehicles, and be brought forward for second and third reading under the bylaw process.

## CITY OF WHITEHORSE BYLAW 2025-27

A bylaw to amend Zoning Bylaw 2012-20

WHEREAS section 289 of the *Municipal Act* provides that a zoning bylaw may prohibit, regulate and control the use and development of land and buildings in a municipality; and

WHEREAS section 294 of the *Municipal Act* provides for amendment of the Zoning Bylaw; and

WHEREAS it is deemed desirable that the Whitehorse Zoning Bylaw be amended to allow for the development of a fence with a maximum height of 1.8 m at LOT 335, PLAN 103882 CLSR YT, municipally known as 10 Eldorado Drive;

NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- 1. Section 12.4 of Zoning Bylaw 2012-20 is hereby amended by adding a new subsection 12.4.7 f) as follows:
  - "f) Lot 335, Plan 103882 CLSR YT, located at 10 Eldorado Drive, is designated PSx(f) with the special modifications being:

Notwithstanding section 5.5.3.4 b) of this bylaw, if the principal use is a temporary shelter, fences and walls constructed in the front yard shall not exceed 1.8 m in height."



## CITY OF WHITEHORSE BYLAW 2025-29

A bylaw to amend Zoning Bylaw 2012-20

WHEREAS section 289 of the *Municipal Act* provides that a zoning bylaw may prohibit, regulate and control the use and development of land and buildings in a municipality; and

WHEREAS section 294 of the *Municipal Act* provides for amendment of the Zoning Bylaw; and

WHEREAS it is deemed desirable that the City of Whitehorse Zoning Bylaw be amended to allow for an eating and drinking establishment with a drive-through component on Lot 117, Plan 103288 CLSR YT, Whistle Bend Subdivision, municipally known as 14 Tarahne Way;

NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- 1. Section 10.9 of Zoning Bylaw 2012-20 is hereby amended by adding a new subsection 10.9.7 d) as follows:
  - "d) Lot 117, Plan 103288 CLSR YT, located at 14 Tarahne Way, is designated CNCx(d) with the special modifications being:
    - (1) An eating and drinking establishment, including a drive-through component is a permitted use;
    - (2) The maximum permitted density of eating and drinking establishments including a drive-through component permitted is 1 per 2.0 hectares;
    - (3) Drive-through queuing spaces shall not be located between the building façade and the fronting public street/side of any building with a drive-through component. Buildings fronting Whistle Bend Way are exempted:
    - (4) Drive-through queuing spaces located adjacent to a street/sidewalk shall be set back a minimum of 2.0 m-from any street, and the set back area shall be landscaped with a minimum of 1 tree or 2 shrubs per 8 m of frontage;
    - (5) To promote visual connection between the building and the street/sidewalk, development is encouraged to incorporate transparent glazing on the ground floor;
    - (6) Any buildings including a drive-through component must provide at least one direct pedestrian walkway between the street and building. Pedestrian walkways shall not cross drive-through queuing spaces; and
    - (7) Eating and drinking establishments with a drive-through component must include indoor dining spaces for seating and ordering.


