1. Zoning Amendment – 163 Collins Lane

An application was presented to amend the zoning of a parcel of vacant Commissioner's land to allow for the expansion of the IS-Service Industrial lot at 163 Collins Lane. As requested by Committee members, Administration provided additional information about the site, surrounding area and setbacks, as well as the Public Hearing process.

The Recommendation of the City Planning Committee is

THAT Council direct that Bylaw 2025-40, a bylaw to amend the zoning of a 2.89 ha parcel of vacant Commissioner's land from PG – Greenbelt to IS – Service Industrial, be brought forward for consideration under the bylaw process; and

THAT Council authorize the use of alternative notification methods in the event of a postal delivery disruption.

2. 2025 Zoning Bylaw

Administration presented the proposed Zoning Bylaw 2025-37 to repeal and replace the current Zoning Bylaw 2012-20 as a result of the adoption of the 2040 Official Community Plan in March 2023. Major topics considered while preparing the new Bylaw included simplification, housing, parking, short-term rentals (STRs), reconciliation, city design, local food and urban agriculture, and administrative and map changes. In response to questions from Committee members, Administration expanded on the proposed regulations for STRs and parking, the community engagement process throughout the project, opportunities for additional public input, and on how future changes can be made if the proposed bylaw is adopted.

The Recommendation of the City Planning Committee is

THAT Council direct that Bylaw 2025-37, a bylaw to adopt the proposed Zoning Bylaw and repeal Zoning Bylaw 2012-20, be brought forward for consideration under the bylaw process; and

THAT Council authorize the use of alternative notification methods in the event of a postal delivery disruption.

3. New Business – Yukon Energy Power Centre Project

A Committee member requested a status update regarding the Yukon Energy Power Centre project, to which Administration confirmed the City is waiting for the proponent's application to begin the process.

4. Delegate Eirik Sharp – Zoning Amendment – 163 Collins Lane

Delegate Eirik Sharp presented concerns about the recreational and environmental impacts of the proposed Zoning Amendment for 163 Collins Lane and requested that Council consider the long-term vision and planning principles outlined by the Official Community Plan during the decision-making process.

CITY OF WHITEHORSE BYLAW 2025-37

A bylaw to provide zoning to regulate the use and development of land and buildings in the City of Whitehorse.

WHEREAS the City of Whitehorse has adopted an Official Community Plan pursuant to Section 278 the *Municipal Act* (SY 2024, c.6); and

WHEREAS section 288 of the *Municipal Act* provides that a council must adopt a zoning bylaw that is consistent with the Official Community Plan; and

WHEREAS Section 289 of the *Municipal Act* provides that a zoning bylaw may prohibit, regulate and control the use and development of land and buildings in a municipality; and

WHEREAS Section 344 of the *Municipal Act* provides that a council may by bylaw provide that in default of payment, an outstanding amount owing may be charged against the real property in respect of which a service was provided or expenditure was made, and that it may be recovered in the same manner as a tax may be collected or enforced under the *Act*; and that a council may by bylaw provide for charging against real property fines that have not been paid as required by the court;

NOW THEREFORE the Council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

Adoption

1. The document titled "City of Whitehorse Zoning Bylaw 2025-37", identified by title and forming part of this bylaw, is hereby adopted.





WHEREAS Zoning Bylaw 2012-20 may be repealed and replaced by Zoning Bylaw 2025-37; and



A bylaw to amend the 2025 to 2028 Capital Expenditure Program Bylaw 2025-06

WHEREAS Section 238 of the *Municipal Act* (R.S.Y. 2002) provides that Council shall by bylaw adopt an Annual Operating Budget and a multi-year Capital Expenditure Program; and

WHEREAS Section 241 of the *Municipal Act* provides that no expenditure shall be made which increases total expenditures above what was approved in the Annual Operating Budget or the Capital Budget unless such expenditure is approved by bylaw; and

WHEREAS it has become necessary to increase the 2025 to 2028 Capital Expenditure Program to provide for advance re-budgeting of the below 2024 Capital Project;
