HISTORY

In accordance with Section 3.1.1 of the Procurement Policy 2020-03, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more, and for procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest. This procurement for construction and Construction Contract Administration (CCA) for the 2026 Asphalt Overlay program is anticipated to be over \$500,000.

The City of Whitehorse owns and maintains the existing road corridors, including road surfaces, paved pathways, concrete sidewalks, curb and gutters, medians and drainage features throughout the City.

In 2023 the City undertook a Pavement Management Program and Condition Assessment to determine the status of all assets and develop a maintenance and rehabilitation program. The report, completed in 2024, identifies roadway segments with lower Pavement Condition Index (PCI) and high International Roughness Index (IRI) values to support strategic reinvestment of the City's annual paved road rehabilitation budget.

The 2026 scope includes high-priority corridors in Porter Creek, Downtown, Riverdale, and Whistle Bend, as well as the intersection of Quartz and 2nd Avenue. These locations exhibit pavement deterioration, drainage deficiencies, and/or operational challenges requiring targeted rehabilitation.

The 2026 Asphalt Overlay project involves the installation, construction and CCA services of:

- Milling and overlay works
- Full depth replacement of asphalt in areas where required
- Improvement of drainage features such as concrete swales
- Commercial crossings where necessary
- Accommodations for new traffic calming, pedestrian or active transportation elements within the existing asphalt surface where applicable

This project aims to:

- Improve the condition and lifespan of Whitehorse roadways;
- Address roadway drainage and performance issues in previously identified areas; and
- Support long-term planning and future reconstruction needs.

This project is currently listed in 2026-2029 Capital Expenditure Program Appendix B and external funding opportunities are being explored to fund \$4.8M.

ALTERNATIVES

1. Authorize Administration to commence the procurement for the 2026 Asphalt Overlay Project upon confirmation of external funding approval and once the project is moved to Appendix A; or
2. Refer the matter back to Administration.

ANALYSIS

The City plans to retain a contractor to for overlay once detailed design is complete in the spring of 2026. Scope will generally include milling and overlay works, full depth replacement of asphalt in areas where required, drainage and access improvements.

Purchasing

Initially, solicitation documents will be publicly issued and the lowest compliant bid will be eligible for contract award. If the public tender results in no bidders, other purchasing methods allowed by the City's policy will be used.

ISSUE

Council approval for to commence the procurement of construction services for project 240c02024 Downtown Sanitary Trunk Main Rehabilitation.

HISTORY

In accordance with Section 3.1.1 of the Procurement Policy 2020-03, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more, and for procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest. This procurement for construction services is anticipated to be over \$500,000.

The sanitary sewer trunk from Wood Street to Lift Station #1 in Shipyards Park was installed in 1955. The trunk varies in diameter from 600 to 750 mm, conveying sanitary flows from Downtown, the Airport, Hillcrest, and Riverdale. This section of the trunk is located within the groundwater table and is exposed to conditions for inflow and infiltration. During sanitary service connection work in 2023, a suboptimal joint was exposed which resulted in a substantial volume of sewage leaking out of the pipe joint requiring reporting the spill to the Yukon Government.

In 2024, the City procured engineering consulting services to perform a condition assessment of the sanitary trunk main and to prepare a conceptual design and options assessment for rehabilitation. The condition assessment revealed several sections of the pipe requiring rehabilitation due to the defects identified and an overall poor condition rating. A cured-in-place pipe (CIPP) was recommended as the preferred method for rehabilitation of the defective segments. A conceptual design has been developed for the CIPP for the high priority areas.

This project is currently listed in 2026-2029 Capital Expenditure Program Appendix B for \$1.2M and is anticipated to be eligible for funding under the Canada Housing and Infrastructure Funds (CHIF) Territorial Stream.

ALTERNATIVES

1. Authorize Administration to commence the procurement for the Downtown Sanitary Trunk Main Rehabilitation Project; or
2. Refer the matter back to Administration.

ANALYSIS

The City will engage with a consultant to develop the detailed design to be ready for tendering in March 2026. The scope of work will include the following services:

- Sanitary Trunk inspection, flushing, cleaning prior to CIPP lining
- CIPP lining design and construction
- Temporary flow bypass design and execution

The conceptual design cost estimate indicates there is sufficient budget to complete the project provided competitive bids are received.

Purchasing

Solicitation documents will be publicly issued as a Request for Proposals (RFP) and the proponent with the highest overall score including technical and price will be eligible for contract award.

Procurement Policy Principles

Compliance: The purchase will follow City policy and procedures for procurement.

Council approval is required to commence the procurement of construction services for project 240c00121 Galena Water Main Improvements.

HISTORY

In accordance with Section 3.1.1 of the Procurement Policy 2020-03, Council authorization is required prior to the commencement of procurements with an estimated value of \$500,000 or more, and for procurements less than \$500,000 that are deemed to be of significant risk, involve security concerns or may be of significant community interest. This procurement for construction services is anticipated to be over \$500,000.

The Galena Road water main, between Tlinglit street and Industrial Road, was installed in 1972 and is reaching the end of service life. This project includes reconstruction of the water main, sanitary sewer main, hydrants, services, and upgrade of the road surface to asphalt.

The watermain and sewer main on adjacent Tlinglit street was reconstructed in 2021 and was also designed and constructed to support Galena watermain project through stubbing out the adjacent water and sanitary sewer mains to facilitate tie-in for Galena watermain project.

This project is currently listed in 2026-2029 Capital Expenditure Program Appendix B in the amount of \$2.4M and is anticipated to be eligible for funding under the Canada Housing and Infrastructure Funds (CHIF) Territorial Stream.

ALTERNATIVES

1. Authorize Administration to commence the procurement for Galena Water Main Improvement Project; or
2. Refer the matter back to Administration.

ANALYSIS

Preliminary consulting work for this project commenced in 2019, which has informed the design. The City engaged a consultant to complete engineering design and is currently finalizing the detailed design to be ready for tendering in March of 2026. The cost estimates indicate that there is sufficient budget to complete the project provided competitive bids are received.

Purchasing

Initially, solicitation documents will be publicly issued and the lowest compliant bid will be eligible for contract award. If the public tender results in no bidders, other purchasing methods allowed by the City's policy will be used.

ISSUE

An application to amend the zoning of a portion of Kwanlin Dün First Nation Settlement Land Parcel C-15B, known as Chasàn Tatäy Subdivision, from PR-Parks and Recreation and RCM-Comprehensive Residential Multiple Family to RCM-Comprehensive Residential Multiple Family and PR-Parks and Recreation, to enable a larger central park and reconfigured residential lots.

HISTORY

An application was received to rezone a portion of the subject site to reconfigure the RCM-Comprehensive Residential Multiple Family and PR-Parks and Recreation zones in the centre of the Chasàn Tatäy subdivision. Kwanlin Dün First Nation (KDFN) intends to develop a larger central park and redesign one large residential lot into four smaller residential lots.

The new proposed park will expand from approximately 0.5 ha to 0.8 ha and will improve accessibility and connectivity to surrounding roads and residential lots. The proposed reconfigured smaller residential lots will maintain the RCM zoning and better align with the capacity of local builders and ensure development feasibility. There is not expected to be any loss in the number of residential units developed because of the proposed zoning amendment.

Bylaw 2026-08 received First Reading on January 12, 2026. Public Hearing notifications were sent out in accordance with the Zoning Bylaw 2012-20, including:

- Newspaper advertisements were posted in the Yukon News on January 16 and 23, 2026;
- Email notifications were sent to Kwanlin Dün First Nation, Ta'an Kwäch'än Council, and the Government of Yukon Land Management Branch;
- Mail notifications were sent to two property owners within 100 metres of the subject site; and
- A notice sign was placed on the subject site.

A public hearing for this item was held on February 9, 2026. No written public input submissions were received and nobody registered for, or spoke to, the amendment at the public hearing.

ALTERNATIVES

1. Proceed with the second and third readings under the bylaw process; or
2. Do not proceed with the second and third readings.

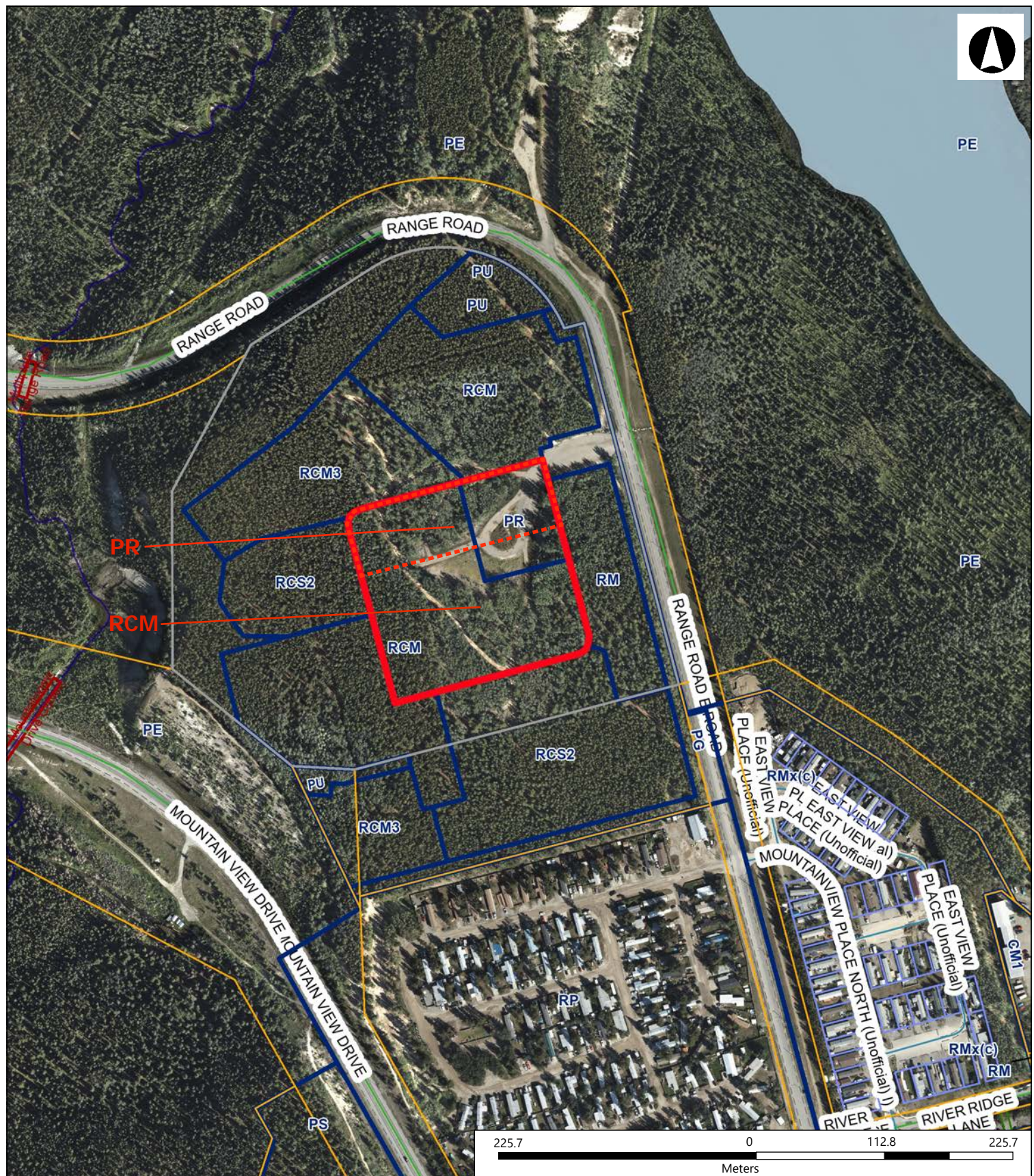
ANALYSIS

No issues were raised with this proposed zoning amendment through the public hearing process and no changes to the application were made following the public hearing. It is anticipated that a subdivision application for Chasàn Tatäy will be introduced to the Planning Committee on March 2, 2026.

The City is currently undertaking a comprehensive zoning bylaw rewrite. The proposed Zoning Bylaw 2025-37 was introduced to the Planning Committee on October 6, 2025. The proposed Zoning Bylaw 2025-37 converts current RCM-zoned properties to the RMM-Residential – Multi-Unit Medium Density zone and current PR-zoned properties to the PAR-Parks – Active Recreation. These zone conversions for the subject site will be incorporated into the proposed Zoning Bylaw and will take effect once it is adopted.

ADMINISTRATIVE RECOMMENDATION

THAT Council direct that Bylaw 2026-08, a bylaw to amend the zoning of Kwanlin Dün First Nation Settlement Land Parcel C-15B from PR-Parks and Recreation and RCM-Comprehensive Residential Multiple Family to RCM-Comprehensive Residential Multiple Family and PR-Parks and Recreation, be brought forward at second and third readings under the bylaw process.

WHEREAS section 294 of the *Municipal Act* provides for amendment of the Zoning Bylaw; and

WHEREAS it is deemed desirable that the City of Whitehorse Zoning Bylaw be amended to allow for the expansion of a proposed park and the reconfiguration of a residential lot on a portion of Lot 1469, Quad 105D/14, Plan 93163 CLSR (Kwanlin Dün First Nation Settlement Land Parcel C-15B);

NOW THEREFORE the council of the municipality of the City of Whitehorse, in open meeting assembled, hereby ENACTS AS FOLLOWS:

1. The zoning maps attached to and forming part of Zoning Bylaw 2012-20 are hereby amended by changing the zoning of a portion of Lot 1469, Quad 105D/14, 93163 CLSR, from PR–Parks and Recreation and RCM – Comprehensive Residential Multiple Family to PR–Parks and Recreation and RCM – Comprehensive Residential Multiple Family as indicated on Appendix “A” attached hereto and forming part of this bylaw.

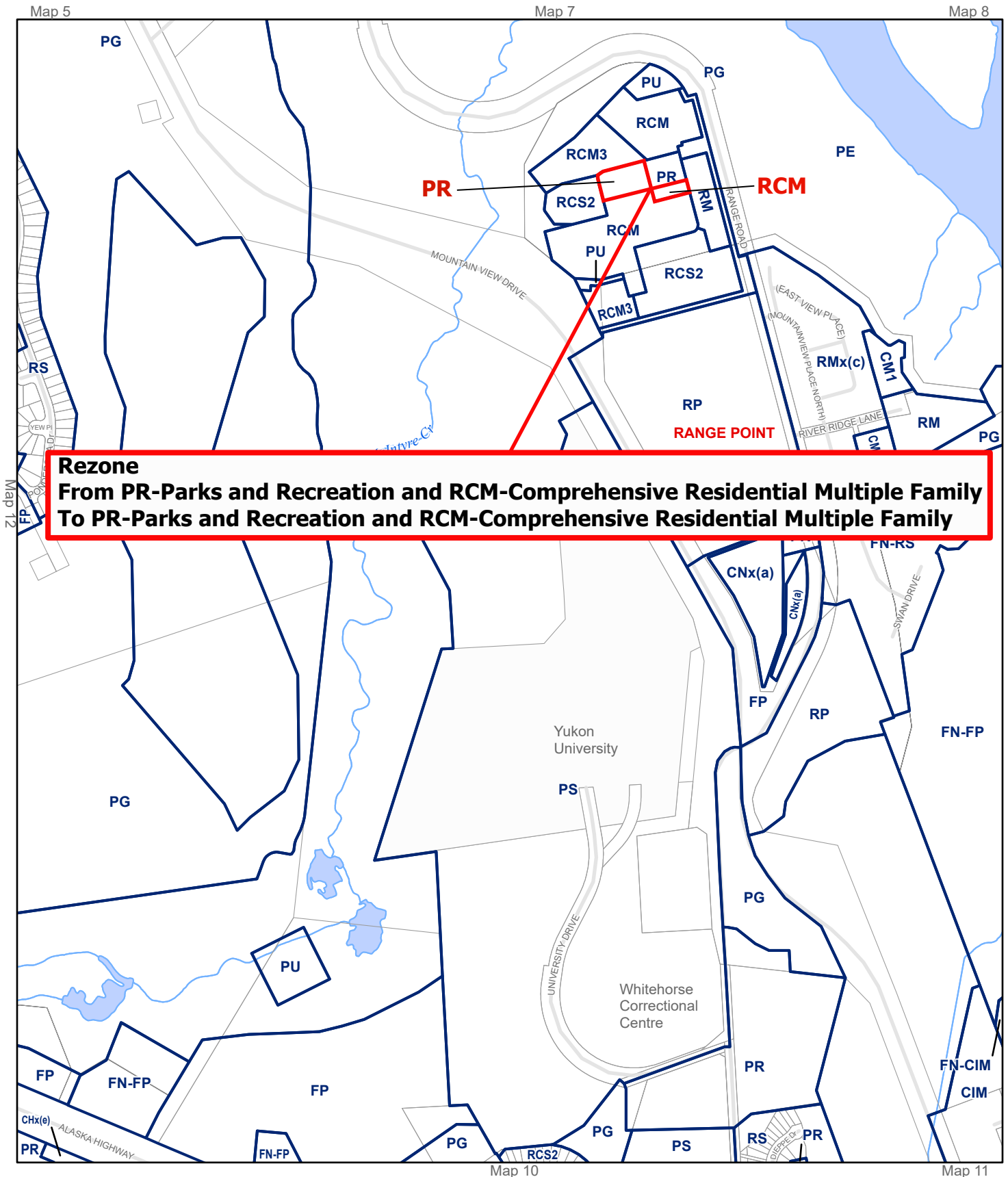
